HB 250, HD1 RELATING TO SCHOOL-BASED HEALTH SERVICES. LHE/HLT, FIN (HSCR731) Formally establishes the Hawaii Keiki: Healthy and Ready to Learn program and special fund within the Department of Education. Status Appropriates funds for positions and a vision screening and eye assessment tool, and to implement, expand, and sustain the program. (HB250 HD1) HB 439, HD2 RELATING TO LAND USE. WLH, FIN (HSCR609) Exempts lands set aside by the Governor to the Hawaii Housing **Status** Finance and Development Corporation for the primary purpose of developing affordable housing from classification as public land subject to DLNR management. HB 897, HD1 RELATING TO THE DEPARTMENT OF LAND AND NATURAL EDB, FIN (HSCR626) RESOURCES. Status Appropriates funds to DLNR Division of Forestry and Wildlife. HB 1593, HD1 RELATING TO INFORMATION TECHNOLOGY. EDB, FIN (HSCR621) Requires the Department of Budget and Finance, in consultation with Status the Department of Accounting and General Services and the Office of Enterprise Technology Services, to develop and procure a uniform financial database for use by all state agencies. Appropriates moneys. HB 747, HD1 RELATING TO DISABLED PERSONS. LAB, FIN (HSCR114) Establishes employment first as a state policy with respect to disabled persons. Requires state and county agencies to implement this policy **Status** in hiring and all programs and services administered or funded by the State or counties. Applies employment first principles to Medicaid home- and community-based waiver programs. HB 1264, HD1 RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM. LAB, FIN (HSCR324) Authorizes forfeiture of certain ERS benefits, pursuant to court order, Status for state or county employees and designated beneficiaries who are convicted of an employment-related felony. HB 34, HD1 RELATING TO WAGES. LAB, FIN (HSCR18) Requires that the foreperson classification be recognized in wage and hour requirements contained in statute and in collective bargaining **Status** agreements for laborers and mechanics on public works projects. RELATING TO WORKERS' COMPENSATION. HB 389, HD1 LAB, FIN (HSCR329) Requires persons performing an independent medical exam or Status permanent impairment rating exam for a workers' compensation work injury examine the employee within an unspecified period of time upon receipt of notice. Requires that the employee be provided a copy of the exam. HB 1195, HD1 RELATING TO FEDERAL WORKERS. LAB, FIN Establishes the Federal Furlough Loan Program to provide loans to (HSCR692) Status eligible federal workers affected by the federal shutdown furlough.

Provides an emergency appropriation to carry out the purposes of the

loan program.

HB 913, HD1 RELATING TO THE HAWAII LABOR RELATIONS BOARD. LAB, FIN (HSCR105) Allows the filing of documents with the Hawaii Labor Relations Board Status by the original paper document or electronically. HB 914, HD1 RELATING TO THE HAWAII LABOR RELATIONS BOARD. LAB, FIN (HSCR106) Clarifies that the party seeking review of a decision and order of the Status Hawaii Labor Relations Board is to bear the cost of preparing a transcript unless otherwise provided by law, in which case HLRB is to bear the cost of preparing the transcript. HB 1059, HD1 RELATING TO FAIR EMPLOYMENT PRACTICES. LAB, FIN (HSCR112) Prohibits noncompete agreements for low wage workers whose earnings do not exceed the greater of the minimum wage required by <u>Status</u> applicable federal or state law or \$15 per hour. HB 1146, HD1 RELATING TO PROCUREMENT. LAB, FIN (HSCR687) Requires consideration of past performance in future bid selection of Status contractors for sole source contracts and any competitive sealed bid or proposal contracts that exceed the small purchase threshold. Requires procurement officers to consider past performance when making a determination of offeror responsibility. Appropriates funds. HB 889, HD1 RELATING TO PUBLIC-PRIVATE PARTNERSHIPS. LAB, FIN (HSCR385) Establishes the Office of Public-Private Partnership and the position of **Status** Public-Private Partnership Coordinator. Adds public-private partnership project delivery methods and related conditions and requirements to the Hawaii Public Procurement Code. Requires an annual report. Appropriates funds. HB 1462, HD1 RELATING TO UNFUNDED LIABILITIES. LAB, FIN (HSCR156) Requires the State Auditor to study the feasibility of providing health Status benefits to state and county employees using a self-insured model. Appropriates funds. Establishes the Rate Stabilization Reserve Fund. Caps employer contributions to the Other Post-Employment Benefits Trust Fund. Provides for the use of a portion of TAT revenues to supplement deficient county public employer contribution amounts. RELATING TO MOVIE THEATERS. HB 1009, HD1 LAB, JUD, FIN (HSCR496) Requires a movie theater to provide at least two showings per week per Status movie offered with open movie captioning. Removes the option of a movie theater to provide eyewear to fulfill the movie captioning requirement. Makes the requirement permanent by repealing the sunset date from Act 39, Session Laws of Hawaii 2015. HB 65, HD1 RELATING TO UNATTENDED VEHICLES. CPC, FIN (HSCR254) Amends the maximum charges imposed for tow truck services. Status HB 1229, HD1 RELATING TO FOOD SAFETY. EDB, FIN (HSCR365) Appropriates funds to the Department of Business, Economic
