HB 297
Status

RELATING TO MOSQUITO VECTOR CONTROL.

HLT/AGR, FIN

Directs the Department of Agriculture (DOA) to review the Aedes aegypti mosquito with Wolbachia bacteria and place it on the appropriate animal import list. Requires DOA and the Department of Health to collaborate on a report to the legislature with recommendations for appropriate vector control programs.

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:

- Testifier's name with position/title and organization;
- The Committee(s) to which the comments are directed;
- The date and time of the hearing; and
- Measure number.

While every effort will be made to incorporate all testimony received, materials received on the day of the hearing or improperly identified or directed, may be distributed to the Committee after the hearing.



Submit testimony in ONE of the following ways:

PAPER: 16 copies (including an original) to Room 403 in the State Capitol;


