Appropriates funds to the University of Hawaii to provide all student-athletes enrolled at the university with two additional meals per day and to provide funds for the UH Athletics Program. (HB1547 HD2)	HRE, WAM
<a href="#">HB1469 HD2</a> <a href="#">(HSCR1217)</a> <a href="#">Status and Testimony</a>	RELATING TO THE COLLEGE SAVINGS PROGRAM. Establishes a state income tax deduction for eligible contributions made to the Hawaii college savings program. (HB1469 HD2)	HRE, WAM
