<u>HB 1415</u> Status	RELATING TO HEALTH INSURANCE. Requires the Director of Human Services to apply for a federal waiver to establish the Hawaii Care Plan to provide health insurance for any individual who is not otherwise eligible for medicaid.	HSH/HLT, CPC, FIN
<u>HB 1451</u> Status	RELATING TO HOMELESSNESS. Extends the Emergency Department Homelessness Assessment Pilot Program and the Medical Respite Pilot Program to June 30, 2020. Appropriates funds.	HSH/HLT, CPC, FIN

DECISION MAKING TO FOLLOW




