<u>SB 1231</u> (SSCR451) <u>Status</u> RELATING TO THE SPOUSE AND CHILD ABUSE SPECIAL FUND.

HSH, FIN

Exempts the spouse and child abuse special fund from the central services assessment and administrative expense assessment. Amends the spouse and child abuse special fund to allow reimbursements received from the U.S. Department of Health and Human Services, Administration for Children and Families, in the year following the fiscal year in which the Title IV-E funds were expended, to be deposited and expended for state-funded share of spouse or child abuse and neglect prevention, intervention, and other related services. Replaces "account" with "fund," and deletes "department of human services" from the title.

SB 947, SD1 (SSCR1019) Status RELATING TO FAMILIES.

HSH, JUD

Prohibits the disability of a parent or caregiver from being the sole factor in determining fitness as a foster parent, adoptive parent, guardian, parent seeking custody or visitation, or provider of a safe family home. (SD1)

SB 1020, SD2 (SSCR1048) Status RELATING TO RENTAL ASSISTANCE.

HSH, FIN

Requires the Department of Human Services to establish a housing homeless children rental assistance pilot program to assist families with minor children experiencing, or at imminent risk of, homelessness due to domestic violence. Requires each family member to obtain financial management and budget counseling services. Requires the Department of Human Services to participate in the Continuum of Care's Coordinated Entry system for homeless services. Requires inputting of data into the United States Department of Housing and Urban Development's Homeless Management Information System. Appropriates funds for the pilot program. Requires report to the Legislature. Effective 7/1/2050. (SD2)
