AFFAIRS' PRO RATA SHARE OF PUBLIC LAND TRUST
FUNDS.

HWN/HRE, WAM

Establishes the OHA's pro rata share of the public land trust.
Transfers funds to OHA for underpayment of the public land
trust funds for 7/1/2012 to 6/30/2019. Requires the DLNR to
provide an annual accounting of receipts from public land trust
lands. Appropriates funds. (HB402 HD1)
