RELATING TO MOTOR VEHICLE TOWING.
Requires a tow truck company not operating under a police department contract to provide a written estimate for services prior to the attachment of a motor vehicle to the tow truck when towing a motor vehicle from an accident. Specifies the fees that may be charged for services.


