### RELATING TO PUBLICLY FUNDED ELECTIONS.

Increases for candidates seeking office in an election with no incumbent, under the partial public funding program: the expenditure limit to one hundred and forty per cent of the median expenditures received by non-publicly financed candidates in the respective voting district in the last preceding general election; the maximum amount of public funds available to a participating candidate; the maximum amount of qualifying contributions; and the matching contribution amount from the

State for qualifying contributions.

Proposes amendments to the Constitution of the State of Hawaii to expressly provide that the legislature may authorize the counties to issue tax increment bonds and to exclude tax increment bonds in determining the funded debt of the counties.

RELATING TO PROPOSED CONSTITUTIONAL **SB 1058** Status &

AMENDMENTS. Requires the attorney general to prepare a statement for each

proposed constitutional amendment in plain English that indicates the purpose, limitations, and effects of the proposed amendment. Requires the office of elections and county clerks

to make the statement available to the public.

RELATING TO HAWAII CRIMINAL JUSTICE DATA CENTER FEES.

**SB 1464** RELATING TO JUDICIAL PROCEEDINGS. JDC, WAM

Status & **Testimony** 

Establishes certain positions in the Department of the Attorney General, Judiciary, and Department of Health dedicated to the preparation, filing, defense, and adjudication of assisted community treatment petitions, related guardianship petitions,

and other legal filings. Appropriates funds.

**SB 1467** 

RELATING TO PROPERTY FORFEITURE.

Status & **Testimony** 

Restricts asset forfeiture to cases involving the commission of a covered criminal misdemeanor or felony offense. Requires seized property to be forfeited only when the property owner has been convicted of an underlying covered criminal misdemeanor or felony offense. Changes the standard of proof that the State must meet in order for property to be forfeited from "preponderance of the evidence" to "beyond a reasonable doubt". Requires the State to prove that owners consented to or possessed knowledge of the crime that led to the seizure of their property. Requires that the agency seizing the property pay for safe and secure storage of the seized property until the completion of the forfeiture proceeding or final disposition of the property. Directs any proceeds from a civil forfeiture to the general revenue fund for public education purposes. Repeals administrative forfeiture proceedings.
