Status

RELATING TO THE HAWAII COMMUNITY DEVELOPMENT LAB, WLH, FIN
AUTHORITY.
Establishes the stadium development district, which includes all state
property under the jurisdiction of the stadium authority, and that
property under the jurisdiction of the Hawaii community development
authority for development purposes. Requires that any state
development in the district obtain a permit from the authority.
Appropriates funds.

Status

RELATING TO CONTRACTORS. LAB, FIN
Exempts an eleemosynary organization that meets certain conditions
from the requirement of licensure as a contractor.

DECISION MAKING TO FOLLOW


