Part I: Allows the department of education to lease public school lands for a term of not more than an unspecified number of years per lease. Part II: Amends Act 206, Session Laws of Hawaii 2017, to allow the city and county of Honolulu to transfer lands under existing department of education facilities directly to the department of education, rather than through the department of land and natural

resources. Takes effect 12/31/2050. (SD2)

Status

Establishes a pilot program to generate revenue through the lease of public library lands to meet the mission of the public libraries. Establishes the library facilities fund. Requires the Board of Education to report to the Legislature. Appropriates funds for a comprehensive

planning study. Effective 7/1/2050. (SD2)
