<u>SB 92</u> Status & Testimony	RELATING TO POLICE REPORTS. Allows surviving immediate family members of murder or manslaughter victims to access a copy of the closing report prepared by the investigating police department, upon the conclusion of all criminal and civil proceedings that arose from the offense.	PSM, JDC
<u>SB 556</u> Status & Testimony	RELATING TO FIREARMS. Adds the requirement to notify the Terrorist Screening Center administered by the Federal Bureau of Investigation to the gun permit application background check.	PSM, JDC
<u>SB 600</u> Status & Testimony	RELATING TO FIREARMS. Provides that no person less than 21 years of age shall bring any firearm into the State.	PSM, JDC
<u>SB 621</u> Status & Testimony	RELATING TO FIREARMS. Requires a person to report the person's lost, stolen, or destroyed firearms to the appropriate county police department. Establishes penalties for failure to report.	PSM, JDC
<u>SB 1040</u> Status & Testimony	RELATING TO SEX TRAFFICKING. Requires the State Commission on the Status of Women to maintain a database on sex trafficking. Requires reports to the Legislature.	PSM, JDC
<u>SB 1321</u> Status & Testimony	RELATING TO FIREARMS. Clarifies that failure to register a firearm within the required time period does not relieve the owner of the duty to register the firearm. Allows the owner of an unregistered firearm to register the firearm thereafter without penalty.	PSM, JDC
<u>SB 1367</u> Status & Testimony	RELATING TO PROMOTING DANGEROUS DRUGS. Establishes the misdemeanor offense of promoting a dangerous drug in the fourth degree for first time offenders who possess smaller amounts of a dangerous drug. Amends related provisions for the promotion of the promotion of dangerous drugs in the second and third degree for consistency.	PSM, JDC

RELATING TO GUN VIOLENCE PROTECTIVE ORDERS.
Establishes a process by which a law enforcement officer or family or household member may obtain a court order to prevent a person from accessing firearms and ammunition when the person poses a danger of causing bodily injury to oneself or another.
