<a href="#">SB 1382</a> <a href="#">Status &amp; Testimony</a>	RELATING TO THE LEGISLATIVE BROADCAST PROGRAM. Requires the legislative broadcast program to make an audio or audiovisual recording of all public hearings and informational briefings held at the State Capitol and maintain an archive of the recordings to be made available to the public.
