Status & Testimony	Beginning after December 31, 2021, requires the department of taxation to track the revenues generated by each industry in the State and requires a report of its findings to be submitted to the legislature no later than twenty days prior to the convening of each regular session.	
Status & Testimony	RELATING TO TAX CREDITS. Increases the allowable income tax credit for low-income household renters to an unspecified amount. Makes the earned income tax credit refundable for ten taxable years beginning after 12/31/2019. Increases the allowable amount of the refundable food/excise tax credit to an unspecified amount.	WAM
Status & Testimony	RELATING TO TAXATION. Increases the state tax credit for research activities to one and one-quarter times the allowable federal tax credit. Amends qualifying tax years.	WAM
Status & Testimony	RELATING TO TAXATION.  Converts the earned income tax credit from a nonrefundable to a refundable tax credit.	WAM
SB 1053 Status & Testimony	RELATING TO GENERAL EXCISE TAX EXEMPTIONS. Establishes a general excise tax exemption for the gross proceeds or income from the sale of groceries that are eligible under the Supplemental Nutrition Assistance Program, regardless of the means of purchase and the SNAP eligibility of the purchaser, and prescription drugs. **SB 1268** RELATING TO TAX REPORTING. WAM Revises the manner in which person authorized to collect rent Status & provides information to the Department of Taxation and requires **Testimony** (as opposed to permits) them to report the total amount of rent collected under sections 237-30.5 and 237D-8.5, Hawaii Revised Statutes. **SB 1271** RELATING TO TAX REFUND OFFSETS. WAM Clarifies that tax refund offsets may be performed by the Status & Department of Accounting and General Services and the **Testimony** Department of Taxation. **SB 1274** RELATING TO DEPARTMENT OF TAXATION FEES. WAM Changes the fees for permits and licenses issued under Status & chapters 243, 244D and 245, Hawaii Revised Statutes, from **Testimony** specified amounts to reasonable fees established by rule adopted by the Department of Taxation. **SB 1275** RELATING TO TAXATION. WAM Makes various technical amendments to chapters 231, 243, Status & 244D, and 245, Hawaii Revised Statutes. **Testimony SB 1360** RELATING TO TAXATION. WAM Requires partnerships, estates, and trusts to withhold taxes on Status & the income of nonresident partners and beneficiaries. **Testimony SB 1361** RELATING TO ESTATE TAXES. WAM Increases estate taxes for Hawaii net taxable estates valued at Measure added Status & on 02-06-19 over \$10,000,000. **Testimony SB 1362** RELATING TO THE CONVEYANCE TAX. WAM Raises the conveyance tax rates for residential investment Status & properties with a value of at least \$2,000,000. Exempts **Testimony** affordable housing qualified by the Hawaii Housing Finance and Development Corporation from the conveyance tax. **SB 1433** RELATING TO TAXATION. WAM Extends the period in which a county may adopt an ordinance to Measure added Status & establish a surcharge on state tax, under certain conditions, on 02-07-19 **Testimony** from 3/31/2019 to 3/31/2021. **SB 1504** RELATING TO TAXATION. WAM Requires a person who prepares or assists in the preparation of Status & a state income tax return, and all the preparer's agents, to obtain **Testimony** a valid and current federal preparer tax identification number. Requires the person who has primary responsibility for the overall accuracy of the tax return to sign the return and provide the person's federal preparer tax identification number. RELATING TO TAXATION. **SB 1516** WAM Reduces taxpayer penalties for nonpayments and Measure added Status & underpayments by setting lower penalty amounts and interest on 02-06-19 **Testimony** rates for earlier rather than later payments of the penalty amounts and interest rates and avoiding penalties and interest if

the taxpayer posts a bond.
