(SSCR196) Appropriates funds for Fiscal Biennium 2019-2021 for Status & operations of the Office of Hawaiian Affairs divisions. Includes operating budgets for Office of Trustees – OHA150; Testimony Administration – OHA160; and Beneficiary Advocacy – OHA175. (SD1) **SB 187, SD1** RELATING TO DISTRICT COURT JUDGES. SB 149, SD1 (SSCR396) Status & Testimony	RELATING TO THE STATE FIRE COUNCIL. Authorizes the state fire council to employ additional staff, contract with any county fire department to fulfill staff positions, and purchase office equipment and supplies.
