Establishes the administrative assistant to the director of human resources development position exempt from chapter 76, Hawaii Revised Statutes, within the department of human resources development. | HB1552 HD2 SD1 (SSCR1446) Status and Testimony | RELATING TO PUBLIC SAFETY. Establishes the Hawaii Correctional System Oversight Commission. Creates a position for an Oversight Coordinator for the Commission. Extends the sunset date of the Reentry Commission to 1/1/2020. Repeals the Reentry Commission and Corrections Population Management Commission on 1/1/2020 and transfers all rights, powers, functions, and duties of those commissions to the Hawaii Correctional System Oversight Commission. Requires the Department of Health and Department of Human Services to work with stakeholders to develop and distribute information about accessing Medicaid services for individuals with intellectual and developmental disabilities. | HB654 HD1 SD1 (SSCR1460) Status and Testimony | <p>RELATING TO HEALTH.</p> <p>Appropriates funds to the University of Hawaii Cancer Center to determine the etiologies of the high incidence of liver and bile duct cancer in Hawaii. Establishes reporting requirements. Effective 7/1/2050. (SD1)</p> | HRE/CPH, WAM |
| HB172 HD1 SD1 (SSCR1249) Status and Testimony | <p>RELATING TO THE BUDGET OF THE OFFICE OF HAWAIIAN AFFAIRS.</p> <p>Appropriates funds for Fiscal Biennium 2019-2021 for the Office of the Trustees (OHA150), Office of Hawaiian Affairs Administration (OHA160), and Beneficiary Advocacy (OHA175). Requires an expenditure of general funds to pay for the auditor to conduct a financial and management audit of limited liability companies created and used by the Office of Hawaiian Affairs. | HB1539 HD1 SD1 (SSCR1525) Status and Testimony | <p>RELATING TO THE HAWAII HEALTH SYSTEMS CORPORATION.</p> <p>Requires Oahu regional board approval to privatize, sell or change services at all Oahu regional facilities. Amends the membership of the Hawaii Health Systems Corporation board. Requires the Oahu regional board to create a five-year sustainability plan in consultation with other government stakeholders and report to the Legislature. Creates a right of first refusal for the Director of Health, Governor's Coordinator on Homelessness, and Mayor of the City and County of Honolulu if the Hawaii Health Systems Corporation board fully or partially privatizes Leahi or Maluhia Hospital.
