### RELATING TO COMMERCIAL MARINE LICENSES.

WLH/TRN, CPC, FIN

Authorizes the DLNR to create different types of commercial marine licenses. Clarifies that commercial marine licenses are required of all

charter and guide services regardless of whether they are tied to a vessel. Exempts commercial marine licenses from the licensing

sanctions for student loan default.
