ALAN HAYASHI

Alan Hayashi is currently the principal of “Consult 808”, a Hawaii based consulting firm specializing in Project Management, Government, and Public Relations.

He was previously with BAE Systems (Support Solutions) as Director of Public Relations and Policy Advocacy in Hawaii for over 4 years. He had been with BAE Systems Spectral Solutions (formerly STI, a Hawaii based optical imaging systems company acquired by BAE Systems) for over 15 years as Director of Government Relations and Community Relations. BAE Systems is a global defence, aerospace and security company, with approximately 90,000 employees worldwide.

Prior to joining BAE Systems, Alan Hayashi was the executive director of the State of Hawaii’s Convention Center Authority for eleven years, and oversaw the location, development, and construction of the \$350M Hawaii Convention Center. Prior to the Convention Center Authority, he worked as a manager in the construction industry, and as a management consultant overseeing development of several major projects, including the \$250M resource recovery facility (HPOWER) for the City & County of Honolulu.

Mr. Hayashi earned a Bachelor of Science Engineering degree from Stanford University, and a Masters of Business Administration degree from the University of Hawaii, Manoa.

Alan Hayashi currently serves, or has served on the boards of directors of the State of Hawaii Workforce Development Council; Go For Broke National Education Center; Military Affairs Council (MAC) of the Chamber of Commerce of Hawaii; Friends of Hawaii Robotics; Gateway Peninsula AOA Board; Hawaii Strategic Development Corporation; Army Hawaii Housing Foundation; Stanford Alumni Association, Georgetown Alumni Club, and the University of Hawaii, Manoa, Shidler College of Business Alumni. He is also a member of The Rotary Club of Metropolitan Honolulu; Friends of Hickam; Navy League; and formerly Hawaii Society of Business Professionals; United Service Organization Hawaii (USO), and Soroptimist International of Waikiki.

Alan's father, Benjamin M. "Ben" Hayashi was born at Hanamaulu, Kauai, a University of California Engineering Graduate, and distinguished Oahu contractor having built many major buildings in Honolulu, including Honolulu City Hall, C. Brewer Offices, Stevenson School, Old Honolulu Stadium, and Pier 2 among others.

Alan's mother, Florence S. Miyaoka - Hayashi was born in Sacramento, California, married Ben and came to Hawaii in 1936. They had four children and were the proud grandmother / grandfather of 7 grandchildren.

After graduating as a ROTC graduate from Stanford University in , Alan entered Army basic officer training at Aberdeen Proving Ground, Maryland. He was commissioned as a Distinguished Military Student and was appointed a Tactical "TAC" Officer, and oversaw the next Basic Officer Training Class at Aberdeen. Alan served briefly with Hawaii's 25th Infantry Division (725th Ordnance Bn), and also with the US Army Reserve (Hawaii Training Center Infantry (HTCI) for a total of almost 7 years.

Alan left military service to join his father's contracting business where he was employed for 28 years. He subsequently worked for Amfac, to manage the construction of the \$250M HPOWER Waste to Energy Facility at Campbell Park. He was appointed the Executive Director of the Waikiki Convention Center Authority in 1989 and served thru completion of the \$350M project in 2000. One of Alan's proudest professional achievements was completion of the Hawaii Convention Center "on time and under budget".

In 2000, Alan was employed by Science and Technology International (STI) thru 2004, when STI was acquired by BAE Systems. He continued to work for BAE Systems as the Director of Public Relations and Policy Advocacy, until his retirement in 2016.
