Dear Chair Rhoads:

Thank you for your letter of January 16, 2019, and for the opportunity to aid in the Confirmation process by providing answers to the specific questions you posed in the letter.

1. Employment Status

On January 3, 2019, Governor David Ige nominated me to serve as Attorney General of the State of Hawai'i. My commission became effective on January 14, 2019, when I officially joined the Department of the Attorney General ("the Department").

2. Role and Responsibility of the Department

The Department provides a myriad of legal services to the State of Hawai'i, and to the people of Hawai'i. As a member of the Governor's cabinet, the Attorney General serves as a legal advisor to the executive branch of state government. The Attorney General also provides legal advice to the Legislature. This advice includes reviewing legislation, providing testimony, and drafting opinion letters and legal documents. The advice provided by the Department assists both the Governor and the Legislature in the discharge of their respective public duties.

As the chief legal officer for the State of Hawai'i, the Attorney General and the Deputy Attorney Generals ("DAGs") become involved in an array of legal issues. In addition to providing legal advice, the Department handles a variety of both civil and criminal matters, including civil litigation, land and natural resource disputes, criminal

investigations and prosecutions, tax matters, oversight of charities and nonprofit organizations, the execution of mandates arising from federal and state statutes, regulatory issues and administrative matters.

In the criminal context, the Attorney General serves as the chief law enforcement officer of the state. The Department investigates violations of state law and maintains specialized units, including units dealing with Medicaid fraud and internet crimes against children. The Department is authorized to prosecute criminal cases in all counties. It also partners with federal law enforcement agencies in the investigation and prosecution of federal crimes.

Importantly, the Attorney General serves as the people's lawyer. The Attorney General is obligated not only to assist the Governor, the Legislature and state agencies, but also to serve the best interests of the public. This institutional obligation is reflected in the fact the Attorney General is the only member of the Governor's cabinet who cannot be removed by the Governor after confirmation by the Senate.

3. The Department's Strengths and Challenges

Based on my two weeks in office, the Department appears to be a well-oiled institution that ably serves the needs of its many clients statewide. The Department has more than 200 attorneys and 500 professional staff. Its sheer size provides both unique capabilities and challenges. As the largest law firm in the state, the Department is well-positioned to take on complicated matters requiring different areas of expertise. It also has talented and dedicated attorneys and staff. The volume of cases and matters, however, presents managerial challenges. While the existing management structure seems excellent, the Department must maintain a mechanism that identifies issues and matters that require a higher level of oversight attention. This effort should come from the top down, which is why I have met as many of the supervisors and line DAGs as possible in my first couple weeks. During these meetings, I have sought to understand the priority issues in each Division and to evaluate how best to address them.

As part of my effort to become familiar with the Department, I am working to identify its top budget priorities. Ensuring that the Department has the necessary equipment to perform its myriad functions is critical. Along those lines, we will need to upgrade computer systems and technology, especially in the criminal and investigation departments. In addition, initiatives related to victims of domestic violence, sex trafficking and other crimes are important budget priorities. The Department needs funding to support its leadership role in making its initiatives successful, and to provide the basic equipment necessary to serve its clients and the public. Finally, ensuring that we can attract talented attorneys is paramount, which means we need to be competitive in the salary arena.

4. Qualifications to Serve as Attorney General

I believe my criminal and civil litigation experience will help me get up to speed quickly on many of the matters the Department is handling. I have handled all phases of civil and criminal proceedings, including the investigation, preparation, trial and appeal of cases. I understand the dynamics, sensitivity and significance of criminal investigations and prosecutions, as well as the resources and skills that are needed. My experience handling substantial tort and civil litigation also will assist me in evaluating civil matters involving the state.

In addition to having litigation experience, I also understand how to work on the operations side of a large organization. Prior to law school, I was the Operations Coordinator for the City of New York, Parks Department. I was involved in developing and implementing a variety of initiatives related to public projects, beaches, pools and park properties. I was involved in labor matters, capital improvements and numerous issues that required collaboration with different divisions in the Parks Department as well as with other city, state and federal agencies. Having worked in an organization with many employees, obligations and responsibilities, I was exposed to different models of leadership. The most effective leadership came from those who led by example, which is what I hope to do. I look forward to advocating on behalf of the State of Hawai'i in cases before our state and federal courts, and to embodying the type of professional commitment I expect to see from employees in the Department.

5. Potential Conflicts

Because of the nature of my civil practice, conflicts may arise. I will be vigilant to identify any conflicts, and will abide fully by the Department's protocols and other ethical rules governing the handling of such matters. When necessary, I will recuse myself and enact walls to prevent the inappropriate disclosure of material.

6. <u>Differences Between the United States Constitution and the Constitution of the State of Hawai'i</u>

While both Constitutions protect basic, fundamental rights, the Hawai'i Constitution goes further in identifying the various roles and processes involved in government. It also provides additional protections in certain areas, including, for example, the right to privacy and the protection of children. And, it expressly addresses public health, public assistance and the promotion of a "healthful environment." Moreover, in the Preamble of the Hawai'i Constitution, there is an express reaffirmation that "government of the people, by the people and for the people" must be exercised "with an understanding and compassionate heart toward all the peoples of the earth."

The most notable differences arise from the fact the Hawai'i Constitution expressly addresses issues unique to Hawai'i. These include provisions pertaining to

"Hawai'i's natural beauty and all natural resources," which are "held in trust by the State." Additional provisions expressly address Hawaiian Affairs, including ceded lands and the protection of Native Hawaiian traditional and customary rights.

In short, the Hawai'i Constitution creates obligations on the part of the Department to ensure protection and fulfillment of specifically enumerated rights. I am committed to ensuring that these rights are defended competently in the litigation arena and protected appropriately by law through the Department's legislative review process. I also am committed to ensuring that the Department timely provides advice and other assistance to aid legislators and state agencies effectively.

7. Additional Information and Disclosures

In addition to my work experience, I have been actively involved in a number of professional organizations, including the Hawai'i State Bar Association and the Hawai'i Chapter of the Federal Bar Association. I am a Vice Chair of the Task Force on Civil Justice Improvements and prior to this nomination, was a volunteer arbitrator with the State of Hawai'i's Court Annexed Arbitration Program for the First Circuit. For three years, I also represented the District of Hawai'i as a Lawyer Representative to the Ninth Circuit Judicial Conference and worked with the federal district court to manage its pro bono program. I also have been active with the William S. Richardson School of Law, including co-teaching a class on small business and entrepreneurship, and am on the faculty of the Hawai'i Federal Trial Academy.

As to the very last question, I am not aware of any personal information that could cause embarrassment to the Governor, Department or Legislature.

Although designated to prosecute offenders in mortgage fraud cases, she was very even-handed and even-tempered in that role. What I found especially noteworthy was her exercise of discretion in cases in which the offenders exhibited many mitigating factors prompting her to recommend sentences that were "fair and just." Therefore, it is without hesitation that I encourage the Senate to confirm her as the next Attorney General for the State of Hawaii. She has, and will continue to bring issues for resolution by the courts in order for the public to regain confidence in our Judicial System. The Keith Kaneshiro case is a prime example of Ms. Connors' commitment and courage in this regard.

I had the honor to work alongside Clare E. Connors, your nominee for Attorney General, at the United States Attorney's Office for the District of Hawaii where I have served as an Assistant United States Attorney since 2004.

While Ms. Connor's credentials and resume are truly impressive and impeccable, they don't begin to tell the story of her excellence as an attorney and advocate for the government. During her time at the U.S. Attorney's Office, Ms. Connors was highly respected not only for her intellect but her inexhaustible work ethic and dedication to the missions of the Department of Justice. Throughout her tenure, Ms. Connors was a total team player and always had time for a kind word and smile for anyone in the office no matter their position.

My name is John Teraoka. I am a retired (2005) Special Agent, formerly with the Internal Revenue Service, Criminal Investigation Division. I have 27 years of service. An IRS Special Agent investigates criminal violations of the Internal Revenue Code (Title 26 United States Code (USC)) and related offenses (Title 18 USC).

In the early 2000s, Ms. Clare Connors, an attorney with the Department of Justice, Tax Division, Washington DC, was assigned to prosecute a tax case that I worked on in Hawaii.

The case involved a complex nationwide tax scheme to defraud the IRS using sham trusts. There were boxes of evidence which had to be reviewed before trial. Tax cases are usually prosecuted using circumstantial evidence. This involved voluminous documents. Ms. Connors was in the office day and night and on weekends preparing for trial. Witnesses and records (financial/business/trust) had to be subpoenaed from Hawaii (all four major islands). Alaska to California, Florida to New Hampshire, and most states in between.

Ms. Connors obtained indictments for five defendants on tax and conspiracy violations for multiple years. Each defendant had their own defense attorney. One defendant, who resided in Washington State left the state. He was later arrested in Colorado by the local authorities on a misdemeanor charge, identified as a federal fugitive and extradited to Hawaii.

All five defendants were convicted. One of the longer sentences was for more than 10 years, which in part was based on the total tax liabilities of the defendants and witnesses to the tax scheme.

As I learned by assisting in the prosecution of this past case, Ms. Connors is very intelligent, articulate, organized, responsible, and personable. I hesitate to use these adjectives since it is not complete in identifying all her traits.

TO THE HONORABLE KARL RHOADS, CHAIR, GLENN WAKAI, VICE CHAIR, AND MEMBERS OF THE COMMITTEE:

I write to recommend the confirmation of Clare E. Connors as the Attorney General of the Department of the Attorney General, State of Hawaii.

I have been practicing law in Hawaii since 1981. I submit this testimony in my individual capacity, and not on behalf of my employer. I met Ms. Connors in the early 2000s, when we worked together as Assistant United States Attorneys. I was privileged to work with her for about seven years, and have been her friend since then. I am familiar with her professional skills and personal character. In my opinion, Ms. Connors has a combination of experience, integrity and resolve that will make her an extraordinary Attorney General for the people of our state.

Ms. Connors' academic and professional accomplishments are readily apparent from her resume. She has a diverse base of experience—she was an accomplished student at different universities, a public administrator for the City of New York, a law clerk for a federal judge, a federal prosecutor, and then a private practitioner. Ms. Connors began her legal career as a law clerk to then-Chief U.S. District Judge David Alan Ezra. She spent a year learning federal statutes and case law, and handling civil and criminal matters through trial or compromise. Judge Ezra was a mentor to her, showing her how to resolve disputes dispassionately, on the basis of the facts and law, and without regard to the identity or power of the parties.

Following her clerkship, Ms. Connors joined the U.S. Department of Justice's Tax Division, where she prosecuted tax cases. She travelled to various circuits and appeared before a variety of judges. The work required not only an understanding of the intricacies

of criminal tax law, but also an ability to adjust to the cultures of different jurisdictions. After enjoying success in that role, Ms. Connors decided to return to Hawaii, where she became as Assistant U.S. Attorney. During her seven years with the office, Ms. Connors handled a broad variety of criminal cases involving violent crime, child exploitation, prison disturbances, narcotics, money laundering, Ponzi schemes, tax, fraud and public corruption offenses. Ms. Connors took on many of the office's most difficult cases early in her career. Following the sub-prime mortgage crisis, Ms. Connors spearheaded the office's prosecution of dozens of individuals for loan generation fraud involving false income statements, inflated appraisals and the like. She also prosecuted integrity offenses involving public officials or employees who abused their positions for personal gain.

All of these cases required sophisticated legal skills. Ms. Connors had to lead grand jury investigations, gather the evidence, and apply the law to complex fact patterns. She also had to make nuanced judgments about whether a defendant acted with criminal intent or, if not, whether administrative or civil sanctions were appropriate. In making these judgments, Ms. Connors often worked both as an attorney and team leader. She led the efforts of task forces or working groups comprised of multiple government agencies and representatives of private industry. The participants sometimes had conflicting needs and priorities, and none reported directly to the U.S. Attorney's Office. Ms. Connors nonetheless showed an ability to forge alliances while respecting the disparate perspectives of the participants.

After leaving the U.S. Attorney's Office, Ms. Connors distinguished herself in the handling of complex civil disputes. While representing injured persons, she took on institutional entities represented by some of Honolulu's largest private law firms. She proved to be a tireless advocate who was not afraid to assert her clients' rights in the trial and appellate courts, or in mediation proceedings.

While working in both the private and public sectors, Ms. Connors has given freely of her time to the legal community. She has been active in the Hawaii Women Lawyers Association, a delegate and representative at the United States District Court's District Conference and the Ninth Circuit's Judicial Conference, the author of a Hawaii Federal Appellate Practice Manual, a presenter at numerous legal seminars, and a faculty member of the Hawaii Federal Trial Academy. Ms. Connors also taught a class on entrepreneurship at the University of Hawaii.

Given her background and engagement, it was not surprising that the American Bar Association rated Ms. Connors "unanimously well qualified" when nominated to be a federal judge. Although Ms. Connors never obtained a floor vote on the nomination, that disappointment gives this Senate an opportunity to confirm her for service in another

significant role.

Ms. Connors is not only an outstanding attorney, but also a wonderful person. She is a devoted wife, mother and daughter. She and her husband have demanding careers that require compromises of the sort that many working Hawaii couples face. Ms. Connors has worked hard to assure that her career successes have not come at the expense of her family. She participates in her children's schooling and outside activities, and puts family above all else. When her father fell ill, Ms. Connors became a patient advocate, studying treatment plans, and making sure that he had the best treatment available. I was enormously impressed by how she maintained her career, and supported her siblings, mother and others with grace. Ms. Connors similarly values her personal relationships, and gives freely to friends, regardless of how busy she may be.

I am confident this committee will hear much about Ms. Connors. She is talented, thoughtful and has endless capacity. She is brilliant but humble—although she is generally the smartest person in the room, you would never know it from her demeanor. She is a great listener—even though she does her own research, she listens patiently to all views, regardless of the identity of the speaker. She is a dealmaker—she finds ways to get to "yes," but is not afraid to be firm when necessary. She can multi-task, attack varied disputes, get to the issues, strip the personalities, and find creative, well-reasoned solutions. She has the courage to do what is right (as we have already seen), and not just what is politically expedient. She will be an outstanding Attorney General.

I am proud to support Ms. Connors, and urge this Committee to act favorably on her nomination.
