I am submitting testimony for the nomination of members to the State Rehabilitation Council (SRC). I am testifying in opposition to the nomination before you of the President of the Kona branch of the Association of Retarded Citizens (ARC). If you did not already know, this organization holds and uses certificates of Section 14C of the Fair Labor Standards Act. This section allows organizations to pay people less than the minimum wage. This organization is receiving federal funds and could most certainly pay their employees a decent wage. I would ask you to question this nominee on this practice during the hearing tomorrow. I would also oppose the appointment of Art Cabinalla to this position as well. Art may be a qualified individual for this position, however, he has not been willing to champion the legislative issues that we have had for the past two years in this session. Unless Art is willing to champion the march for ending sub minimum wage payments for the blind and all others with disabilities, then I would recommend you not appoint him for this position.
