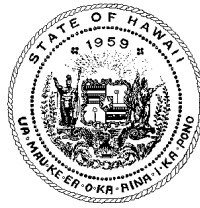

Chair Dela Cruz, Vice Chair Keith-Agaran, and Members of the Committee:

The Department of Public Safety (PSD) appreciates and strongly supports the Proposed Senate Draft (SD) 2 of House Bill (HB) 456, House Draft (HD) 2, which provides for an emergency appropriation of \$5.3 million for the immediate repair needs of the Maui Community Correctional Center (MCCC), which was heavily damaged in a facility disturbance on March 11, 2019. HB 456, HD 2, SD 2 (Proposed) also authorizes the director of finance to issue general obligation bonds in the amount of \$8 million for the long-term rehabilitation of MCCC.

Both the emergency appropriation and the funding for MCCC's long-term rehabilitation are necessary to address immediate repairs and long-standing infrastructure improvements for the safety and security of the facility's inmates, staff, and the surrounding community.

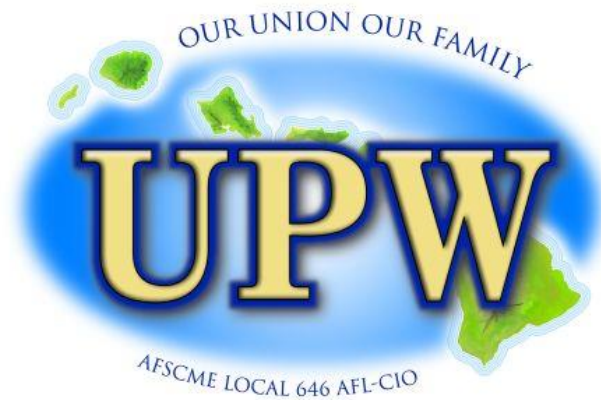

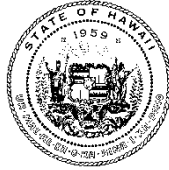
