- 1 **Fiscal Implications:** The Department of Health (DOH) defers to the Department of
- 2 Transportation (DOT) regarding the implementation and fiscal impacts of this bill, and to the
- 3 priorites set forth in the Executive Biennium Budget Request.
- 4 **Department Testimony:** HB757 requires the Department of Transportation to adopt a Vision
- 5 Zero policy to eliminate all traffic fatalities in Hawaii. This measure proposes a working group,
- 6 which would be responsible for developing an action plan, including a combination of
- 7 engineering, enforcement, education, and emergency response strategies. The Vision Zero policy
- 8 differs from previous approaches to traffic safety efforts by emphasizing strategies that will
- 9 benefit the vulnerable and underserved populations.¹
- 10 The DOH stands ready to participate on the Vision Zero working group and will collaborate with
- the Department of Transportation, other key state and county agencies, and community
- organizations towards the goal of eliminating serious injuries and traffic fatalities.
- Over 40 cities across the US have become vision zero cities. According to the National Highway
- 14 Traffic Safety Administration (NHTSA), in 2016 Hawaii ranked 5th worst in the nation for
- speed-related traffic fatalities. During the last decade, Hawaii has been above the national

- 1 average for alcohol impaired driving fatalities. HB757 provides a mechanism for state agencies
- 2 and the legislature to support data-driven solutions to help reverse this trend.²

DOT strongly believes that a strong multifaceted approach using legislation, enforcement and education is what is necessary to reduce the number of fatalities and injuries that are occurring on our State's roads. Furthermore, strong community and legislative support, in addition to establishing stronger laws, will result in the reduction of motor vehicle fatalities and injuries.

Dear Chair Aquino and Committee Members,

I thank you for the opportunity to provide testimony supporting the intent of HB 757, requiring the Department of Transportation and the counties to adopt a Vision Zero policy with the ultimate goal of preventing and eliminating all traffic fatalities.

In Hawai'i County, Mayor Harry Kim will be issuing a Vision Zero proclamation on February 1, and the Hawai'i County Council's Public Works and Mass Transit Committee will take up the attached Resolution No. 38-19 adopting the goals, policies, and strategies of Vision Zero on February 4, with possible Council approval at its February 20 meeting.

We do not have a single Hawai'i County "transportation department" as referenced in HB 757, and alternate language should be adopted to clarify who from Hawai'i County shall be appointed to the working group. In our local efforts, multiple county agencies and departments will be involved in ensuring the safety of our residents and visitors, among them Public Works, Planning, Fire, Police, Liquor Control, the Prosecuting Attorney, Mass Transit, Research and Development, Information Technology, and the Office of Aging.

This has been a tragic week for pedestrians on Hawai'i roads. Any steps that the State and the Counties can take to reduce the number of future victims will be welcome.

RESOLUTION NO. 38 19

A RESOLUTION ADOPTING THE GOALS, STRATEGIES, AND POLICIES OF VISION ZERO TO PREVENT TRAFFIC-RELATED FATALITIES AND INJURIES.

WHEREAS, according to the State of Hawai'i Department of Transportation, 32 people were killed in traffic-related incidents in Hawai'i County in 2018, and seven of last year's deaths were pedestrians or cyclists, compared to five pedestrian/cyclist deaths in 2017, representing a 40 percent increase in pedestrian/cyclists deaths; and

WHEREAS, the root causes of traffic collisions are often related to policies, systems and environments that can be improved upon with collective action and political will; and

WHEREAS, roadway infrastructure policy has a substantial impact on traffic, bicycle, and pedestrian safety; and

WHEREAS, no one should die or be seriously injured while traveling on roadways; and

WHEREAS, Vision Zero is a comprehensive strategy to eliminate all traffic deaths and severe injuries while promoting safe, healthy, and equitable mobility for all; and

WHEREAS, the fundamental message of Vision Zero is that all traffic deaths are preventable and unacceptable; and

WHEREAS, following the initial implementation of Vision Zero in Sweden in the 1990s, the death rate for motorists in Sweden has been cut in half since 2000, and pedestrian fatalities have also declined 50 percent since 2009; and

WHEREAS, major American cities including Los Angeles, New York City, Seattle, San Francisco, Portland, Philadelphia, Boston, Chicago, Denver, Fort Lauderdale, and Washington, D.C., have adopted Vision Zero policies that focus on safety as a primary objective in designing transportation projects; and

WHEREAS, Resolution No. 171-11, Draft 2, adopted on October 19, 2011, established a "Complete Streets" policy, in support of safe mobility for all roadway users in Hawai'i County; and

WHEREAS, Vision Zero in Hawai'i County will be implemented through a proclamation from the Mayor, the adoption of its policies by the Council, and the establishment of a diverse task force comprising representatives from County departments and agencies, the State of Hawai'i, and private nonprofit organizations; and

WHEREAS, the Vision Zero Task Force will meet regularly to create a County of Hawai'i Vision Zero Plan, which among other things will prioritize data collection, traffic enforcement, pedestrian safety around schools, and the design and construction of safe roadways, shoulders, intersections, and pathways; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI'I that the goals, strategies, and policies of Vision Zero are adopted to prevent traffic-related fatalities and injuries.

BE IT FINALLY RESOLVED that that the County Clerk shall transmit a copy of this resolution to the Mayor, the Managing Director, the Director of Public Works, and the Director of Planning.

SUBJECT: Testimony on House Bill 757 - Relating to Vision Zero

The Department of Transportation Services supports the intent of this measure, and recognizes Vision Zero as a proven approach to prevent and ultimately eliminate traffic fatalities in Hawaii. Vision Zero is a welcomed departure from the status quo because it relies on data-driven strategies and places urgency and accountability on system designers and policymakers.

Vision Zero is a priority of the City and County of Honolulu. Our department is already implementing Vision Zero strategies through its Complete Streets Program and proposes a Vision Zero Action Plan to the Oahu Metropolitan Planning Organization to identify high crash locations, prioritize projects, and develop educational materials. The City Council has also adopted Resolution 18-219, *Urging the City Administration to Adopt the Goals, Strategies, and Policies of Vision Zero.*

We support the mandated adoption of the Vision Zero policy by the State and counties; however, given the context-specific nature of successful Vision Zero plans, we request your consideration of an amendment to allow for individual action plans and working groups for each jurisdiction, to be driven by the respective jurisdiction.

Hawaii needs to appropriate adequate funds so that people have funds to travel to meet at regular in-person meetings, develop and print materials, provide staff time for the department of transportation, and additional activities as needed (e.g., bring in external vision zero experts for assistance).

Safety over speed.

We need to prioritize safety over speed. Everyone deserves a safe street, whether you are walking, bicycling, using transit, or driving. Protecting lives and preventing injuries should be our most important goal.

I do not want to see another tragedy like the one we saw in Honolulu on Monday, January 28, 2019. Three people died at one intersection. They were all pedestrians. They were all innocent. They were simply waiting for the light to change so that they could walk in the marked crosswalk across the street to Ala Moana Park. In an instant, they were gone. This is NOT an accident. This is a crash.

This is traffic violence.

And all of us are affected.

I feel so much pain for those families who lost loved ones this week. I know that pain. I too have experienced the heart-wrenching pain of losing a family member in a traffic crash. That pain runs deep and it stays there just below the surface. It is always there. We cannot let this happen again. We need to do better.

Support saving lives and preventing injuries. Support Vision Zero.

Chair Aquino, Vice-Chair Hashimoto and Members of the Transportation Committee:

Mahalo for hearing this measure that calls for better ways to address the tragic deaths on our state and local roads. We support HB 757.

Brought to Hawaii by HMSA, Blue Zones Project helps increase the overall well-being of our communities to make Hawaii a healthier, happier place to live, work, and play. To accomplish that goal, we address ways to lower obesity rates, tobacco use, and chronic diseases.

At Blue Zones, we try to increase opportunities for people to move naturally throughout their day. Currently, our shared public right of ways discourage natural movement. In 2018, 43 pedestrians were killed compared to 38 motorists, and in total road deaths, 117 people were killed. There needs to be a radical, comprehensive, systematic approach to addressing safety on our roads. By working together, we can increase the safety for all road users. Vision Zero is not just a plan or a policy, it is a wholistic approach to safety by using data, street design, driver education, and pedestrian awareness.

Tragically, three individuals were killed in a horrific crash on Monday evening. Although it happened all at once, this scene is not unfamiliar. Again and again people are killed on our roadways. A single death causes great loss and sorrow to family, friends, and our community. Speeding, distracted driving, and intoxication are all major contributors to these deaths.

Vision Zero, a strategy to eliminate traffic fatalities, originated in Sweden in 1997, when it was adopted as the official road policy founded on the core belief that loss of life was not an acceptable price to pay for mobility. In the United States, large and small cities from coast to coast have been recognized as Vision Zero Communities by the Vision Zero Network. By implementing a variety of strategies many lives have been saved. In 2017, through adoption of Vision Zero, both San Francisco and New York City have seen the lowest traffic related fatalities since record keeping began in the early 1900s.

Vision Zero approach identifies the places where the highest incidences of fatalities occur, and then utilizes polices and best practices to systematically address the deadly situations. Our roadways need to be made safe for our most vulnerable users.





Currently, Maui County, City and County of Honolulu, and as of 9 AM this morning, the County of Hawaii have formally committed, through resolution or proclamation, to the process of bringing Vision Zero to their counties. Kauai recently passed their street design manual into law, which calls for "safer streets for all". This county work is to ensure the safety of all the road users by taking into consideration people with all physical abilities. Working to implement their Complete Streets Plans, creating Vision Zero implementation plans, collecting data, collaborating on ideas, and reaching out to the Vision Zero Network for best practices and support are all ways to amplify safety.

This bill requires a collaborative effort with county, state, and other involved groups. It is important to have strong working collaborations with the state department of transportation, county transportation entities, highly invested groups such as law enforcement and AARP, as well as other community groups like PATH.

We would request that The Peoples Advocacy for Trails Hawaii should be included into the working group. They have done extensive work at the county level for Vision Zero but have also been influencers in advancing statewide conversations.

We believe that the time has come to more effectively address this major issue. Many people have been working together to achieve a safer community. This measure will help coordinate the efforts.

Aloha Chair Aquino, Vice Chair Hashimoto, and members of the Transportation Committee:

Thank you taking time to read my testimony in **SUPPORT** of HB757, requesting the State of Hawai'i to adopt a Vision Zero policy.

As a public health professional that drives a car, bikes, and walks throughout urban Honolulu, I cannot stress how important it is that we prioritize street safety for the benefit of our entire community. I recently attended the vigil for the three pedestrian lives lost at the recent horrible crash in Kaka'ako, both to pay my respects and raise attention to the fact that we can do more to prevent such crashes. Through better street engineering, enforcement, education, evaluation, and policy changes, we can work across sectors to address this major issue, and I strongly believe Vision Zero provides an effective framework to do so.

Vision Zero is a collaborative, comprehensive road traffic safety program founded in Sweden that aims for zero traffic fatalities or serious injuries. Since its founding, Sweeden has become a leader in road safety and has seen traffic fatalities cut in half from 1996 to 2016. This multidisciplinary approach brings together local leaders in health, traffic engineering, and law enforcement to create policies and practices to improve the safety of travel.

Vision Zero has since been adopted by over 20 major U.S. cities since 2014, including New York City, San Francisco, Washington D.C., and Austin. After adopting Vision Zero, San Francisco benefited from a 41% reduction in pedestrian deaths from 2013 (a year before Vision Zero was implemented) to 2017, a year that the city recorded the lowest traffic fatalities since 1915. Since implementing Vision Zero in 2014, New York City has benefitted from four consecutive years of declining traffic fatalities, ending 2017 as the safest year on record with a 28% decline in traffic fatalities and a 45% decline in pedestrian deaths from 2013 (a year before Vision Zero was implemented) to 2017.

Again, I absolutely support polices that make places where people live, work and play healthier and happier, and encourage this committee to pass HB757. Street fatalities and serious injuries are preventable.

The Obesity Prevention Task Force of the Hawai'i Public Health Instituteⁱ is in **Support of HB757**, which creates a temporary working group to assess and develop a plan to adopt a vision zero policy for the state.

We applaud the legislature's commitment to creating safer, more livable streets with the goal of eliminating all traffic fatalities and reducing severe injuries. Injuries are not accidents — they are predictable and preventable. Vision Zero is a growing movement in cities across the nation that focuses on improving transportation systems and infrastructure for vehicle traffic as well as for people who walk, ride bicycles, and use other forms of transportation. Vision Zero is a bold vision that is not only possible, but necessary.

HIPHI convenes Healthy Eating, Active Living coalitions in each county. We have supported the Complete Streets law passed by the legislature in 2009, and Bill 26 passed by the Honolulu City Council in 2012. HIPHI has been working with each of the county councils to support the goals of Vision Zero. On September 15th, Mayor Arakawa signed a proclamation to adopt the goals of Vision Zero and eliminate traffic deaths on Maui by 2040. We ask the legislature to consider including a representative from HIPHI to serve on the working group and to provide any support to help promote and improve pedestrian safety and mobility for all residents.

Testimony in Support of HB757 Relating to Transportation

Aloha Representatives Aquino,

On behalf of Peoples Advocacy for Trails Hawaii (PATH), I am writing to express our strong support for the Safe Passing bill HB757.

This bill requires the department of transportation and the county transportation departments to adopt a vision zero policy that seeks to prevent and ultimately eliminate all traffic fatalities through a combination of engineering, enforcement, education, and emergency response strategies that focus on equity. It also establishes a temporary working group to develop an action plan and review certain specified traffic policies and guidelines. This working group will report to legislature in 2020 and 2021. The bill also calls for funds to be appropriated

In 2018, there were 32 fatalities on Hawaii Island roads alone.

Hawaii County has the highest number of roadway fatalities per capita in the state In January of this year, we have already had 2 fatalities, compared to 0 at this time last year.

This is why at 9:00 on February 1, 2019, Hawaii County Mayor Kim is proclaiming that a Vision Zero task force be formed to eliminate traffic fatalities.

We strongly support the creation of a working group to develop a statewide plan that will support and augment the counties efforts to reach zero fatalities.

The premise of Vision Zero is that all of these fatalities and countless serious injuries could have been prevented. Vision Zero starts with the ethical belief that everyone has the right to move safely in their communities, and that system designers and policy makers and community members share the responsibility to ensure safe systems for travel.

Vision Zero is a data driven multidisciplinary approach, bringing together diverse and necessary stakeholders to address this complex problem. In this working group meaningful, cross-disciplinary collaboration among local traffic planners and engineers, policymakers, public health professionals and community members from all counties will be the norm.

Vision Zero acknowledges that many factors contribute to safe mobility -- including roadway design, speeds, behaviors, technology, and policies -- and sets clear goals to achieve the shared goal of zero fatalities and severe injuries. A working group made up of those who have already start to develop a plan and those who are just getting started will greatly accelerate to development of a statewide Vision Zero plan.

Vehicle collisions are the leading cause of violent physical death in Hawaii, United States, and the world in general, with Hawaii having one of the highest pedestrian fatality rates in the U.S., killing more people than guns. When Vision Zero is implemented in other cities in the United States and around the world, one of things people ask first is how many pedestrian fatalities is acceptable. People of course will say a number. But then advocates ask next, how many members of your immediate family are you okay with being hit by a car, everyone says zero. And every single person who gets hit is someone's immediate family member, all of their deaths are tragic.
