I strongly support the appointment of Mike McCartney to the position of director of the department of business, economic development, and tourism.

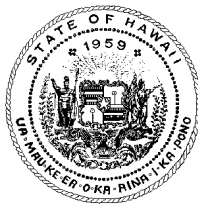
I currently work with Mike in my capacity as director of finance and previously in various other capacities.

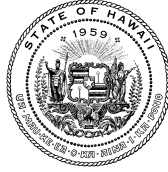

The Department looks forward to working with Mr. McCartney as we address the difficult issues related to climate change and the impacts of tourism on our natural resources.

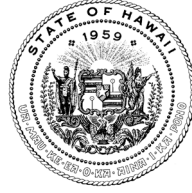

I firmly believe Mr. McCartney will continue to be a valued and highly productive member of Governor Ige's cabinet, and respectfully request that you recommend

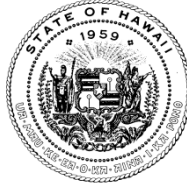

Thank you for the opportunity to submit written testimony in strong support of Governor's Message 664, nominating Mike McCartney as Director of the Department of Business, Economic Development and Tourism for a term of office expiring December 5, 2022.

Hawaii's economic growth has slowed in 2019, and the state faces multiple threats to its visitor-based economy, including homelessness and conflicts between traditional visitor accommodations (like full-range hotels, time-share and condo-tel properties), and emerging 'home-sharing' alternatives that have proliferated throughout Oahu and the neighbor islands.

Against this backdrop, DBEDT Director-nominee McCartney's extensive business, executive and visitor industry experience provide much-needed skillsets to address Hawaii's economic challenges. A review of the past fifteen years illustrates his contributions during a time of global tumult and instability, especially in the aftermath of the 2008 U.S. mortgage crisis and auto industry bailouts.

As Chair of the Hawaii Tourism Authority (HTA) and President-CEO of HTA during that tumultuous time, McCartney expanded Hawaii's long-standing relationships with Japanese and Korean visitor industry partners and spearheaded development of emerging markets in China, Taiwan, Southeast Asian and Vietnamese markets.

Not only did HTA preside over Hawaii's hosting of the November 2011 APEC Forum at the Hawaii Convention Center, which brought over 10,000 people to Hawaii and brought enormous economic/PR benefits to the state's economy, but the Hawaii Convention Center served as the welcoming venue for the completion of Hokulea's 'Malama Honua' worldwide voyage in 2017.

At the same time, Mike McCartney understands the importance of digital media, music and technology in charting Hawaii's course in the global economy. Through his early business successes as President of "Hawaii Stars" and his role in transitioning Hawaii Public Television from analog to digital into PBS Hawaii today, he has embraced digital storytelling as integral to the expression of Hawaii's aloha spirit.

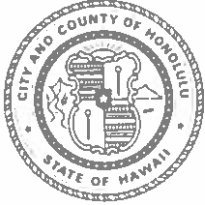
