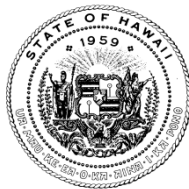

**SUBJECT:** HCR 24 and HR 29  
Requesting the United States Government to Lease Federally Owned Vacant Land to the State of Hawaii to be used as Tow Yards to Store Abandoned Vehicles.

The City and County of Honolulu's Department of Customer Services respectfully submits COMMENTS on HCR 24 and HR 29.

The Division of Motor Vehicle, Licensing and Permits (DMVLP) oversees the abandoned vehicle program through its subsidiary branch, Motor Vehicle Control Section. In review of HCR 24 and HR 29, the DMVLP through the City and County of Honolulu would like to support any and all legislative efforts creating opportunity for the State of Hawai'i to enter into agreements with the U. S. government for discussion on resource allocation. In this case, specifically, the opportunity to lease or be granted a waiver for use of U. S. government property for the exclusive purpose of the storage of impounded vehicles.

Additionally, we would encourage the legislature to consider that the U. S. government has an obligation to be a fiduciary partner to the State of Hawai'i in light of our finding(s) that a sizable contribution to the abandoned vehicle problem is directly correlated to the transportation and acquisition of vehicles by U. S. service members. It, therefore, seems only appropriate the U. S. government would be a party to the solution regarding the epidemic posed by abandoned vehicles across all islands, and, specifically, the Island of Oahu."

Aloha, Chair Henry Aquino and Vice Chair Troy Hashimoto, and Committee members. I am Chair for the Pearl City Neighborhood Board No. 21 and I am submitting this testimony as an individual in SUPPORT to HCR 24 / HR 29.

This resolution requests the U.S. Government to lease federally owned vacant land to the State of Hawaii to be used as tow yards to store abandoned vehicles.

This problem continues to fester because our residents are reporting numerous abandoned vehicles throughout their neighborhoods that are taking up parking spaces from our citizens who truly need a place to park their vehicles. The City does not have the lot space for towing these abandoned vehicles.

Solution for mitigation of abandoned vehicles: The State, City and Federal government and develop a Memorandum of Agreement to store the vehicles for a set period of time for no fee. This should be a mutual mitigation plan that benefits all. In addition, a plan of action needs to be developed to expedite moving these abandoned vehicles off our beautiful island because we don't need to keep these storage lots full until someone figures out what they will do with them. A Pearl City resident suggestion was to prepare the vehicles for the environment by extracting the oil and fuel from the vehicles and build an artificial reef way offshore for the fishing industry. This is what the Navy does with their excess "moth ball" ships as they sink them off of the island of Kauai for their military exercises. They set the example by preparing the ships for the environment removing oil and asbestos.
