On the following measure: S.B. 770, S.D. 1, RELATING TO REAL ESTATE LICENSES

Chair Ohno and Members of the Committee:

My name is Michael Pang, and I am the Chairperson of the Hawaii Real Estate Commission (Commission). The Commission strongly supports this bill and offers an amendment.

The purpose of this bill is to require a high school education or its equivalent as a condition for obtaining a license as a real estate broker or a real estate salesperson.

In 1977, the Legislature established the Hawaii Regulatory Licensing Reform Act (Act) under Hawaii Revised Statutes (HRS) chapter 26H. The major policy of the Act states, "the purpose of regulation **shall** be the protection of the public welfare and **not** that of the regulated profession or vocation" (emphasis added). The Legislature further recognized the necessity of creating additional protections for the public when it established the Commission. The Legislature defined the Commission's purpose in HRS section 467-4 as "the protection of the general public in its real estate transactions."

The Commission believes that requiring a high school education as a minimum qualification for licensure ensures that having an educated licensee population is one of the most important ways to protect consumers in their real estate transactions. However, requiring the Act to apply to newly licensed persons at their first renewal, as stated on page 4, lines 9 to 11 of this bill, may raise constitutional legal questions regarding a licensee's property rights. Furthermore, S.D. 1 is contrary to the purpose stated in section 1 of the bill, which is to enact this requirement prior to licensure. To avoid any unintended consequences, the Commission prefers the original language of this measure and suggests the following amendment to page 4, lines 9 to 13: "This Act

shall apply only to [renewal applicants seeking their first license renewal before

December 31, 2020, and] new applicants who are applying for licensure as a real estate broker or salesperson for the first time on or after the effective date of this Act."

We are lagging in one of our most basic of educational requirements by not raising the bar to a standard that requires that new real estate licensees have a High School Diploma (HSD) or General Education Development (GED) equivalency to be licensed as a real estate agent in Hawaii.
