 entity have continued to pursue the national organization's mission,
 working closely with judicial system stakeholders and the broader public to
 study and promote a range of improvements to judicial selection, retention,
 and accountability, judicial ethics, access to the courts, and the criminal
 justice system in the State of Hawaii.
- 2. The goals and objectives related to the request;
 The goal of this request is to help fund the AJS National Convention, which will be held in Honolulu on November 22-25, 2020. The theme of the conference, "Judicial Independence in the Age of Political Polarization,"

was inspired by recent developments impacting the American justice system, including issues relating to judicial elections and the role of campaign fundraising, diversity in the courts, and public understanding of and confidence in the court system. The AJS convention will be attended by judges from across the country, attorneys (including many former numbers of the national AJS organization), and interested community leaders, who will learn from conference panelists, invited legal experts, and active jurists.

- The public purpose and need to be served;
 The conference will serve as the catalyst to share with judicial experts from around the nation that Hawaii would be the best base for a national movement for judicial reform. Support for this is evident here: Hawaii has a strong and independent judiciary, a well-tested and successful merit selection process, a diverse judiciary (perhaps the most diverse state judiciary in the country), and an effective judicial accountability system (through its commission on judicial conduct, its judicial evaluation system and its judicial retention system). For those throughout the country who wish to exchange ideas and thoughts about reform, Hawaii is a formidable laboratory.
- 4. Describe the target population to be served; and
 The target population includes students and anyone in the community who
 is interested in Judicial Independence and better understanding the court
 system both in our state and nationally.
- Describe the geographic coverage.
 The Conference will be open to any individual who wants to learn more about he court system throughout all islands.
