GIA CIP funding is requested by Homestead Community Development Corporation (HCDC) in the amount of \$350,000 to purchase a solar panel energy system and lithium battery system for installation on an existing certified kitchen located in the rural community of Anahola. The public purpose of this request, is to support the economic impact on small and micro businesses owned by residents on Kauai that use the certified kitchen, by lowering kitchen use fees that support the utility costs of the facility. This project directly serves the public need of having access to a low cost certified kitchen to produce food products by locally owned ad operated food operators on the island of Kauai. HCDC has focused on the targeted group of Hawaii citizens residing on the island of Kauai, from Kekaha to Haena.

II. Background and Summary

1. A brief description of the applicant's background;

The Homestead Community Development Corporation is an incorporated Hawaii nonprofit, founded in 2009 to address affordable housing and economic development. HCDC has developed 22 single family homes on Oahu and Kauai, and is in predevelopment on a 3 acre multi-family project in West Oahu, and has developed numerous economic development projects that create jobs in rural areas of the State. For example, HCDC has constructed a certified kitchen serving small micro-enterprise food hub businesses, an enterprise center delivering small business training, and partnered on a solar facility that funds economic development projects for entrepreneurs.

HCDC's background and expertise includes the operation of a community loan fund for ranchers, farmers, micro-business, as well as families to upgrade safe housing, bedroom additions, and other consumer purposes. Its loan fund delivers financial literacy, family budgeting, and in late 2019, HCDC has logged 16 families within a 2-month period, requesting assistance in the area of foreclosure prevention. The State of Hawaii, DHHL reports over 200 families are currently in a loan delinquency situation, which the HCDC program will be directed at assisting.

HCDC is governed by a 5-member board of commissioners, and a 5-member elder council, with seats dedicated to Kauai, Oahu, Maui, Molokai and Hawaii Island. It is a 11-year old, mature nonprofit, with offices on Oahu, Kauai and Maui, and is led by an experienced CEO.

2. The goals and objectives related to the request;

The goal of the HCDC Solarized Certified Kitchen Project is to reduce the utility expense on a public purpose, nonprofit certified kitchen owned and operated by HCDC, in order to reduce fees paid by local micro-businesses to sustain the facility.

Objectives include 1) purchase and install a commercial solar panel energy system and lithium battery system on a 10 year old certified kitchen; 2) reduce certified kitchen user fees to increase economic impact and profitability of small local food service businesses that access the certified kitchen.

3. The public purpose and need to be served;

GIA CIP funding is requested by Homestead Community Development Corporation (HCDC) in the amount of \$350,000 to purchase a solar panel energy system and lithium battery system for installation on an existing certified kitchen located in the rural community of Anahola. The public purpose of this request, is to support the economic impact on small and micro businesses owned by residents on Kauai that use the certified kitchen, by lowering kitchen use fees that support the utility costs of the facility. This project directly serves the public need of having access total low cost certified kitchen to produce food products by locally owned ad operated food operators on the island of Kauai.

A successful installation of an independent solar panel system is estimated to reduce current annual utility costs at the certified kitchen by \$30,000. Reduction of facility overhead will result in the ability of HCDC to reduce certified kitchen fees to local users by up to 40%, supporting viability and success of local businesses in need of a certified kitchen. The cost reductions from reduced utility expense will also enable HCDC to invest in additional and affordable retail space adjacent to the certified kitchen, and expand its bathroom facilities to service patrons to the East Kauai region, all from utility cost savings.

4. Describe the target population to be served; and

Hawaii citizens residing on the island of Kauai, from Kekaha to Haena. The availability of nonprofit certified kitchens are minimal, yet certified kitchens are in high demand for one of the top areas of locally owned and operated value-added food vendors.

Describe the geographic coverage.

The Anahola Marketplace certified kitchen is located in east Kauai in Anahola, however, it serves the entire geographic area of the county of Kauai.

HCDC is an incorporated Hawaii nonprofit, founded in 2009 to address affordable housing and economic development on or near Hawaiian Home Lands. As such, for 11 years, it has operated programming in building affordable homes, building community facilities that create jobs, and delivering direct technical assistance to entrepreneurs and families in mostly rural homestead areas to strengthen financial capacity and business and family prosperity, regardless of homestead residency. HCDC is a community development financial institution, funded by the U.S. Treasury to deliver loans and financial services to residents of homestead communities statewide.

HCDC constructed a certified kitchen on Hawaiian Home Lands in 2009 to serve the entire island of Kauai and its residents, through a competitive grant award by the U.S. Department of Housing & Urban Development, under its Alaska Native/Native Hawaiian Institutions Assisting Communities program. The facility was qualified because of its location on Native Hawaiian trust lands in the homestead region of Anahola, Kauai. However, its use is not limited to Native Hawaiians, and is available to support residents of the County of Kauai.

HCDC is capable of completing this project, based on its development of the certified kitchen itself, as well as its construction of another community facility in west Kauai, in Kekaha.

Moreover, HCDC is led by a CEO with 28 years of executive management experience in finance, construction, business and community development projects. HCDC also has on staff, three Program Managers with excellent experience in private sector investment finance, corporate retail management experience, project management and social enterprise operations.

In the last 3 years, HCDC has been awarded government grants to provide technical assistance to small and micro business entrepreneurs and agricultural related family businesses, and to provide financial literacy services to families. In the last 3 years, HCDC has been awarded private foundation and agency funds to deliver services to build rural economies in Hawaii, and in 2019, HCDC was awarded \$300,000 in federal and private capital for its homestead loan fund.

2. Facilities

HCDC maintains 3 physical offices in the State of Hawaii, located on the island of Oahu, Maui and Kauai. In addition, HCDC owns and operates an Enterprise Center, a Certified Kitchen and an open air marketplace with a business incubator providing a dozen retail spaces for local entrepreneurs. This GIA request would direct funding to improve the 10-year old certified kitchen to upgrade to a solar and battery system to reduce costs that will further reduce costs to local entrepreneurs on the island of Kauai.

It has audited financial statements, a sophisticated accounting system based on multiple funding sources and projects, which requires an excellent management structure, with experienced leadership. HCDC has excellent policies and procedures in place, which includes staff development and training. As a nonprofit community development corporation, HCDC has developed and maintains community facilities, ensuring its capacity to complete the Solarized Certified Kitchen project.


