- 3. **Services Supported:** Honolulu Habitat for Humanity (HHH) is applying for its Home Build program. Through community outreach, HHH identifies potential partner families who qualify for a Habitat home. Families participate in financial education and home ownership classes ensuring they are prepared for the financial obligations of home ownership. Once families are qualified, they are given a 30 year, no interest loan for their home, and HHH coordinates the volunteers and corporate donations needed to make their home a reality. Our partner families are required to give 'sweat equity' hours working right alongside our volunteers. Families work alongside Honolulu Habitat's staff and thousands of volunteers to construct their homes at 60% below market rate.

Honolulu Habitat for Humanity's mission is to bring people together to build homes, communities and hope. HHH partners with low income families to build quality, affordable homes, and repair homes that have fallen into disrepair. Honolulu Habitat for Humanity was founded in 1988 and has built more than 80 homes on the island of O'ahu, sheltering more than 400 people

#### 2. The goals and objectives related to the request;

Honolulu Habitat for Humanity is applying to the state GIA for operational support to start the construction of 10 homes for low-income families on the island of Oahu. Families who are receiving homes have applied and are in the process of being accepted as Honolulu Habitat for Humanity partner families. Applications and projects will be approved by the Honolulu Habitat for Humanity Board of Directors. The families will have an active role in the construction and completion of their homes. These 10 homes will shelter approximately 35 individuals.

#### 3. The public purpose and need to be served;

Honolulu Habitat for Humanity greatly offsets the costs of building homes due it its corporate sponsorships, donations, and volunteer labor. As a result, families who could otherwise not afford their own homes can emerge as homeowners, which benefits not only the current but future generations of a family.

# 4. Describe the target population to be served; and

Our target families are in the 30% (extremely low income) - 60% (very low income) range of Area Median Income (AMI) for the county of Honolulu. In general, our applicants are living in inadequate housing, living with other family members, or paying rent that overstretches their budget. Homeownership is a crucial foundation for helping low-income families find a path out of poverty. When they move out of substandard housing and into simple, quality, affordable homes, homeowners and their families improve their health, educational attainment, safety and personal wealth.

#### 5. Describe the geographic coverage.

Our service area is designated as the island of Oahu.

Honolulu Habitat for Humanity's evidence-based model of self-help housing is drawn from the history and experience of its national affiliate, Habitat for Humanity International, which has over 40 years of experience as a global leader in addressing the issues of poverty housing. All of Honolulu Habitat for Humanity's programs, services, and activities were chosen because they fit into Habitat for Humanity International's evidence-based strategies, and can increase home ownership among low-income families in our community and give homeowners the skills to maintain and keep their homes.

Honolulu Habitat for Humanity will be working on constructing 10 homes (Home Build projects) during the funded year. Houses and communities impacted are Waimanalo and Kaneohe. Families who are receiving homes and renovation services have applied and been accepted as Honolulu Habitat for Humanity partner families, and will have an active role in the construction and completion of their homes. These homes will shelter approximately 35 individuals. Supported by hundreds of other community volunteers, each family will contribute 'sweat equity' hours by assisting in the construction and renovation of their homes, and be required to attend financial literacy training to ensure they are able to pay their zero-interest loan payments. Housing costs for these families are greatly subsidized by in-kind donations, volunteer labor, and community support which makes homeownership a reality these low-income families could not otherwise attain. During the funded year, Honolulu Habitat for Humanity will also hold 8-10 community outreach sessions to educate the community about home ownership.

Habitat for Humanity is the largest residential home builder in the world, bringing the reputation, strength and backing of the Habitat International to the table.

HHH also bring strong public and private partnerships to the table, and continues to expand its knowledge of housing issues to best serve our community. In the past 3 years, Honolulu Habitat for Humanity has built 13 homes, renovated 6 houses in disrepair through the Home Preservation Program, worked with more than 6,000 volunteers, and provided repair services through our Build Aloha program to multiple community organizations.

HHH has built more than 80 homes on Oahu since our founding, sheltering more than 400 people. We have direct experience providing shelter, homeowner training, and financial literacy training.

Honolulu Habitat for Humanity's offices are located in the Kalihi area of Honolulu. This large facility space allows us to collect and store donations for our home builds.
