Although our organization is newly organized (May 2019), our core group of carvers have been doing carving demonstrations for over 20 years. Our carving demonstrations include the actual first cuts on the log to the finished lashings of the canoe. Our demonstrations are hands-on, open to the public, with safety our top priority. In the past, dependent upon what was wanted, we have included "talk-story" sessions, a fold-out display on the process of canoe carving, and a 7ft. canoe that can be dismantled into its' parts.

This travelling exhibit will be run exactly as we have run our canoe carving demonstrations, with 2 additions: 1, the canoe from England; and 2, the showing of our documentary (we've completed the trailer). Thus, outside of shipping the canoe from England, our costs are minimal, as we have everything else, our documentary will be done by June 1, 2020.

The documentary will tell the story of this project which is pretty amazing as it weaves in the Maori from New Zealand, the Smithsonian Museum in D.C., us Hawaiian canoe carvers, Queen Kapi'olani, England and Queen Victoria, and also the Wolastoqiyik tribe from Canada. This inspiring story of international cooperation, philanthropy, environmental stewardship, Hawaiian history, Hawaiian culture and spirituality, all told in a contemporary narrative with the canoe as the vessel. the Queen Kapi'olani Canoe Project.

All of the other costs as minimal as we have one display made, we will be finishing the documentary in May 2020, and we have been doing canoe carving demonstrations for the past 20 years.

A brief description of the applicant's background;

Hua O Lahui's mission is dedicated to the betterment of Native Hawaiians and Hawaii, through education, culture, economics (including housing) and health by supporting, starting, and continuing programs/events that support Native Hawaiians and Hawaii Our organization's governing structure consists of 4 Trustees, who also makes up the executive team (president, vice-president, treasurer, secretary). None of the Trustees/Executive team gets paid.

Our funding experience is limited as we only formally organized in May of 2019. However, we have received \$5750 from Hawai'i Island Councilmembers to conduct 2 canoe carving demonstrations in Hilo (Merrie Monarch) and Honolulu (FestPac 2020), as well as sponsorships from Stihl for chainsaws, Southwest Airlines for airfare, Big City Diner for food, and Matson for shipping.

Prior to our formal organization in May 2019, our core group of carvers, led by master Hawaiian canoe carver (one of the few remaining) Ray Bumatay, have done over 20 canoe carving demonstrations, e.g. Merrie Monarch and Lahaina's International Festival of Canoes, to demonstrations in New Zealand, Japan, England, Washington D.C., Seattle, and Washington. Our schedule for 2020 include canoe carving demonstrations at Merrie Monarch, FestPac 2020, IVF World Sprints, and Japan.

Our demonstrations include canoe carving, lashing workshops, a display on canoe carving and a 8ft canoe that is in pieces (dismantled).

2. The goals and objectives related to the request;

- *perpetuate and present authentic Hawaiian culture
- *educate the people of Hawaii on the philanthropic life of Queen Kapi'olani
- *promote environmental stewardship as we use the canoe to highlight and connect the importance of a healthy forest to a healthy ocean
 - *tell the inspirational story of this project through international cooperation
 - *acknowledge the knowledge and skill of master canoe carver Ray Bumatay
- -all of this tied, to this historically and culturally significant canoe in a storage facility in Dereham, England.

The public purpose and need to be served;

We will be perpetuating the disappearing practice of canoe carving. Very few people carve canoes in today's world where it is faster and less expensive to plank a canoe. Ray Bumatay might be the last master Hawaiian canoe carver.

We will be promoting environmental stewardship which is of critical importance for our island State.

We will be teaching and inspiring the people of Hawaii with the story of Queen Kapi'olani and the story of this project. The healthy well-being of our community rests upon the inter-relationship of how we conduct ourselves, environmental stewardship, and empathy for our fellow humans. This travelling exhibit has the opportunity to affect the people of Hawaii for our betterment.

And, we will be bringing this gift of a canoe, back home, to tell its' story, to have the people of Hawaii, who carved this canoe and put their "mana" into this canoe, back in Hawaii, among the people of Hawaii.

4. Describe the target population to be served; and

Our target population is the entire State of Hawaii and visitors who will be in Hawaii at the time. We will be pushing this narrative through our marketing efforts of our canoe carving demonstrations in 2020. We will then build upon those efforts as we specifically promote the travelling exhibits in 2021. Our documentary will be able to reach a large portion of the population through the internet. We also feel that our documentary has the potential to be aired on public/network television which would exponentially increase our reach.

5. Describe the geographic coverage.

All of Hawaii, but we feel this story has the capability to be expanded to the Nation and even internationally as Washington D.C., New Zealand, England, and even Canada is now involved in this project.

We have no one on salary, no stipends, no wages, no paid consultants. All volunteers who believe in this project and this cultural practice.

- -Project Lead is Zak Shimose, overall responsibility for the entire project and overseeing/supporting each delegate to ensure success of all the different parts.
- -Responsibility for shipping of the canoe from England to Hawaii is Zak Shimose, Amy Somers of Momart art shipping, and Samantha Johns of Norfolk Museum Services. Zak will be responsible for payment to Momart, receiving the canoe in Hawai'i and packing/crating canoe to the freight forwarder. Amy will be responsible for all the

logistics for shipping the canoe. Samantha will ensure that Amy/Momart has completed all the necessary steps.

- -Eric Kai will assist Zak with coordinating with Amy and Samantha.
- -Once a facility is secured, Ross Andre will be in charge of coordinating with the Oahu facility.
- -Once a Hilo facility is secured, Shannon Poe will be in charge of coordinating with the Hilo facility.
- -Concerning securing facilities Zak, Eric, Ross, and Shannon are working on getting a facility for Oahu and Hilo.
- -For the exhibit, Zak will be in charge of the displays, and coordination for the showing of the documentary. Ray Bumatay will be in charge of the carving demonstration.
- 2. Provide a projected annual timeline for accomplishing the results or outcomes of the service:

Once funds are secured, Momart will begin the permitting process and logistic coordination with Norfolk Museum, which will take maximum of 8 weeks to complete. As we have done and continue to do carving demonstrations, we are able to put together a demonstration in one week. For this exhibit we will construct 2 displays which will be complete by December 1, 2020.

We will have a facility in Hilo and a facility in Honolulu secured by June 1, 2020. The idea for a travelling exhibit was only started on December 21, 2020. In between Christmas and New Years we have been getting estimates from art shipping companies and conceptualizing the project. We have reached out to Iolani Palace, Hawaii Convention Center, and Imiloa Museum (Hilo) during the week of January 7, 2020. All have been very receptive towards this project, and we will continue to reach out to potential facilities to include hotels and government facilities.

The 2-week exhibit will start in Hilo during Merrie Monarch 2021. Then another 2-week exhibit will be held in Honolulu during May/June (we will try to run it alongside another event).

In case Momart Art Services are unable to fulfill their services, another premier art shipping company, Gander and White, will be utilized. The actual exhibit with the carving demonstration will not be a problem as we many of our core carvers can run a carving demonstration, as always with the highest safety standards employed. The 3 displays will be made to accompany the canoe, so the exhibit itself should be problem free. And, our core group of carvers are interchangable, so staff sickness/vacancies will not be an issue.

We have received funding from Hawai'i County council members for phase 1 of the Queen Kapi'olani Project. We will go back to the Council members to solidly potential support for this, phase 3 of the Queen Kapi'olani Project, should there be cost over-runs

due to an increase in Momart's estimate or the currency exchange fluctuates, as their estimate is in British pounds.

We will have a count of all attendees/participants. We will be using quick surveys (on ~75% of attendees) to find out attendee/participant ethnicity and residence. We will utilize a little more in-depth survey to measure attendees/participants level of satisfaction, knowledge of cultural practice and Hawaiian history prior to and post-exhibit, and ideas on improvement (on ~50% of attendees). We will have one person dedicated to do daily surveys and attendance. We will use the surveys to improve our exhibit.

Our core group of carvers led by master canoe carver Ray Bumatay has been carving canoes for over 50 years, and doing canoe demonstrations for over 20 years. 2000-2005 - Participated as the only Hawaiian canoe carvers at Lahaina International Festival of Canoes.

2006 - Carved a wa'a for and with Kamehameha-Keaau Middle School students. That canoe is still displayed in front of the office.

2011 - Canoe carving demonstration in Japan for the Japan Canoe Racing Association.

2016 - Canoe carving demonstration in Hilo for the County of Hawaii.

2017 - Consultant for Smithsonian Museum in D.C. for the 3d reconstruction scan of Queen Kapi'olani's canoe.

2018 - Canoe carving demonstration in Japan.

2019 - Canoe carving demonstration of replica of Queen Kapi'olani's canoe at Merrie Monarch.

2019 - Consultant in England to visit and record the canoe.

2019 - Canoe carving demonstration in New Zealand as part of Tuia 250 celebration.

As part of these canoe carving demonstrations we usually have a fold-out display to accompany the carving, so this exhibit will be run very similar to our past carving demonstrations. We would really be adding a finished canoe and 2 more displays, and one dedicated surveyor.

We will have 3 displays for the exhibit, 1 is already made.

And, all of the resources needed to do a carving demonstration are to be provided by Our organization, Hua o Lahui.

We will have the facilities secured by June 1, 2020.


