Since 1947 Imua Family Services has been dedicated to the mission of "providing comprehensive early childhood development services to children and their families with the support and resources needed to achieve their full potential in life". Over the years, Imua Family Services has consistently expanded the level of services available for Maui families and currently provides an extensive array of family-centered, community-based, transdisciplinary services for infants, toddlers, and preschool children, birth to age six and their families. Imua takes a multi-faceted systems approach to Early Childhood Development integrating the: promotion of family well-being (i.e. through parent coaching, support networks and capacity

building), prevention/intervention (i.e. outreach, education and proactive screenings/assessments), and treatment (i.e. direct therapeutic services). By impacting the life trajectories of children and families at this critical stage, Imua creates significant positive impact upon the communities that surround them.

2. The goals and objectives related to the request;

Imua Family Services shines a light on Maui as being the largest early childhood development provider in the State, providing the most innovative and progressive services to families. Due to the expansion of our Maui community and the increasing number of children requiring services, it is time for Imua to expand its operations. This, in conjunction with the need to expand to more diverse and progressive forms of therapy is why we are looking to grow. Opportunities to coach families and provide additional parent training opportunities, and our ongoing efforts to become a fully sustainable nonprofit organization all lead to our decision to expand. The goals of the Imua Family Discover Gardens is to inspire children to learn and grow, and equip parents and teachers to support this process by creating a safe place where learners of all abilities can grow at their own pace. This natural play space will encompass natural playgrounds, childcare centers, an outdoor amphitheater, family picnic spaces, and gardens where children can connect, play, and learn in nature in a placebased manner. Our objective is to create a more independent, sustainable agency through the acquisition of this space and expansion of the programs and services we provide to the community.

Studies show that the creation of outdoor learning environments contributes to healthy development, and spark cognitive growth and creativity. It improves attention for children living with ADHD and improves challenging behaviors while nurturing their emotional development. A second Imua Inclusion Preschool will be opened to serve both typically and non-typically developing children between the ages of 3 and 5 years old. We also plan to open a toddler center for children with special needs to provide child care for their families and help to provide some recuperation time for the families while the children are nurtured and well cared for. This property will also provide immediate housing temporarily while newly recruited staff that is new to Maui integrates into our community and find permanent housing. Many of our staff is recruited from off island and this will lower barriers for our community getting the highly trained early childhood pediatric professionals we need to serve our keiki. A Tea House meeting space will also be created.

3. The public purpose and need to be served;

The purpose of Discovery Garden is to inspire children to learn and grow, equip parents and teachers, and to be a "safe place" where learners of all abilities can grow at their own pace. In a Nature Play Space "nature play spaces" encompass natures learning grounds, childcare centers, outdoor learning amphitheater, family nurturing spaces and gardens where kids can connect, play, and learn in nature. Our project will help restore children's relationship with families and develop a sense of place and connection.

Additionally Imua will open a second state of the art Imua Inclusion Preschool doubling our preschool program capacity. The target population to be served is children of all ability levels and their families. Imua Family Discovery Gardens allows children of all ability levels the opportunity to discover their environment in a truly interactive way. Discovery Gardens lets children with disabilities play right alongside their able-bodied friends and siblings. Ramps, bridges, and transfer stations will allow everyone to reach the highest deck of equipment. Mud tables, interactive walls, and activity panels are easily accessed by all. The sensory garden will provide a series of integrated spaces that are devoted to the seven senses of seeing, hearing, touching, tasting, and smelling, vestibular and proprioceptive. This barrier-free playground promotes acceptance and compassion, both important values for children to embrace.

5. Describe the geographic coverage.

Imua Family Discovery Gardens will be located in the heart of Wailuku on 6.09 acres, and accessible to all residents of Maui, and visitors from neighbor islands and beyond.

Spring of 2020, we will launch our formal capital campaign, while simultaneously completing the acquisition of The Yokouchi Estate 6.09 acre property in Wailuku, in order to create the Imua Family Discovery Gardens. The feasibility study has already been completed and planning and design will commence. A capital campaign manager, along with staff leadership will complete the capital campaign in 12-18 months. Executive Director, Dean Wong, will act as the Project Manager and lead the process from start to completion. A team of architects, planners, designers and contractors have been assembled and are ready and willing to support this process. Leadership is in place and prepared to support this expansion with staff development, marketing, and communications as needed. We will restore, renovate, and revitalize The Yokouchi Estate to provide an incredible value add to our community.

All staff are in place and as expansion occurs, additional hires can be brought on and appropriately trained for maximum community impact.

Imua Family Services is primed and ready to take on this next expansion to better serve our community and create the Imua Family Discovery Gardens campus. We are already working with architects and planners to make this a successful endeavor.

In FY13, Imua Family Services and Easter Seals Hawaii negotiated an agreement and implemented initial planning for the development of a new 10,000+ s.f. state-of-the-art facility to provide office space and program areas specifically designed to accommodate the needs of Imua Family Services clients. This consisted of a partial demolition of an existing two-story building that was formerly used as a dormitory for seasonal workers by Maui Land & Pineapple and the new construction of a two-story steel framed building utilizing the existing foundation and structural support systems. This approach enabled Imua to develop the project at a relatively low total cost and significantly reduce the amount of time required for pre-development activities and the completion of construction. The total cost of the project was \$1,915,000 (which included a 10% construction contingency) and it was projected that once all funding was in place the construction can be completed and the facility ready for occupancy in 3 – 6 months. A capital campaign was launched and this was successfully completed on time under Executive Director, Dean Wong's watchful eye and leadership.

2. Facilities

In April 2015, Imua Family Services completed the Imua Family Services Early Childhood Development Center in Kahului which houses our offices and most center based therapy activities. We opened a West Maui Family Center in 2017 to assist therapists and families who live on Maui's west side avoid commuting on the Pali with small and infant children. And we opened an Imua office at the Molokai Community Health Center so that all of our comprehensive services can be offered to families and children on Molokai.

The next phase of Imua's expansion of services and growth is upon us and to meet these needs Imua Family Services is planning to purchase The Yokouchi Estate 6.09 acre property in Wailuku, in order to create the Imua Family Discovery Gardens. A feasibility study was completed and the Imua Family Services Board of Directors approved to move forward with the purchase negotiations of this building. Already, \$2.8 million has been secured in-kind, and as a donation, to help make this vision a reality for our community.
