The K.E.L.I.I. Foundation is requesting \$272,213.57 for the public purpose of opening the first transitional housing facility in Kapolei in conjunction with piloting the first ever transitional program in the State of Hawaii that will directly service Youth (14 years and older), Women, Needy, At-Risk, and Disabled individuals and their families and caretakers. In order to transport Clients of this transitional program to and from Campbell High School to Kapolei and the Kahumana Learning Center in Waianae, the K.E.L.I.I. Foundation is also requesting monies for a passenger van to safely transport Client's with Autism and other special needs and their caretakers.

# II. Background and Summary

1. A brief description of the applicant's background;

The Keiki Education Living Independent Institute (K.E.L.I.I. Foundation) was brought into existence on June 20, 2012, by the Haole family and was named after their child Kelii, who has a genetic neurodevelopmental disorder.

#### 2. The goals and objectives related to the request;

The K.E.L.I.I. Foundation's mission is to help individuals with Autism and other special needs to have a higher quality of life. This year, the K.E.L.I.I. Foundation is focusing on creating and piloting the first-ever transitional program in the State of Hawaii called "Bridge the Gap Transitional Program" by partnering with Bridge the Gap, Inc. and Kahumana Learning Center.

Objective #1: In relation to this request, the K.E.L.I.I. Foundation will be opening its first transitional housing facility in Kapolei. This grant will partially fulfill the K.E.L.I.I. Foundation's long-term vision to build a multi-disciplinary center and transitional housing facility that would provide an integrated system of care comprised of multiple service providers.

Objective #2: To best serve the transitional program's Clients, the K.E.L.I.I. Foundation will be providing transportation, which has also been requested within this grant.

#### 3. The public purpose and need to be served;

The objective of the K.E.L.I.I. Foundation's Bridge the Gap Transitional Program is to seamlessly transition young adults with special needs from the Department of Education in to independent living. Currently, there are no programs in the State of Hawaii that address this need specifically for individuals with special needs. The K.E.L.I.I. Foundation will partner with Bridge the Gap, Inc. and Kahumana Learning Center to spearhead this program.

#### 4. Describe the target population to be served; and

The target population served includes Youth (14 years and older), Women, Needy, At-Risk, and Disabled, along with their families and caretakers.

#### 5. Describe the geographic coverage.

The K.E.L.I.I. Foundation's Bridge the Gap Transitional Program will service the **West side of Oahu**. In the near future, with necessary funds and resources, we plan to expand the Bridge the Gap Transitional Program to the entire island of Oahu.

# III. Service Summary and Outcomes

Objective 1 – Ensure the K.E.L.I.I. Foundation's first transitional housing facility is ADA compliant. This will include major renovations to the Kapolei transitional housing facility's residence, including, but not limited to: remodeling the kitchen and bathrooms to be ADA compliant, changing out windows, widening all doors throughout the facility, upgrading all electrical throughout the facility, and building an accessory dwelling unit (ADU) above the newly-covered patio at the rear of the facility for 24/7, on-site caretakers.

Objective 2 – Provide transportation for the K.E.L.I.I. Foundation's Bridge the Gap Transitional Program. Participants of the Bridge the Gap Transitional Program will be transported frequently between Campbell High School, the transitional program's housing facility, Kahumana Learning Center, and other K.E.L.I.I. Foundation events and activities. In the near future, the K.E.L.I.I. Foundation is hoping to expand it's Bridge the Gap Transitional Program to Kapolei High School, where the same need for transportation will be present.

2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;

Renovations to the K.E.L.I.I. Foundation's first transitional housing facility will take 3-4 months within the release of funds. The passenger van is a one-time purchase that will be purchased immediately upon the release of funds.

3. Describe its quality assurance and evaluation plans for the request. Specify how the applicant plans to monitor, evaluate, and improve their results; and

In order to ensure that the K.E.L.I.I. Foundation housing facility is ADA compliant and deemed safe and appropriate for its participants, the K.E.L.I.I. Foundation plans to replace all windows in the facility to be plexiglass and/or some type of unbreakable material. They will be replacing and widening all doorways in to and out of the facility as well as into each bedroom, bathroom, etc...for ADA compliance. Since the current residence was built in the 80's, the K.E.L.I.I. Foundation will be upgrading all electrical throughout the facility for electrical safety purposes. Additionally, the funds will be used to open up and expand the kitchen, so participants have enough space and adequate appliances to practice cooking, washing dishes, and preparing meals. Last, but certainly not least, the K.E.L.I.I. Foundation plans to create an outdoor lanai/patio area with an accessory dwelling unit (ADU) built on top of the proposed lanai for the overseers and caretakers of the housing facility. The lanai/patio area below will create a safe space for the Bridge the Gap Transitional Program participants to socialize outdoors in a comfortable, safe environment.

Secondly, the K.E.L.I.I. Foundation will be purchasing a 2019 passenger van (see attached proposal) to transport Bridge the Gap Transitional Program participants to and from Campbell High School, the K.E.L.I.I. Foundation's housing facility, and the Kahumana Learning Center. Private transportation is so important, as public transportation is simply not an option for many

of our children and young adults with autism and other special needs, especially those with violent outbursts or behaviors. This vehicle will help alleviate many financial burdens from the participant's skills trainers as many use their own private vehicles to transport Clients, which adds wear and tear to their private vehicles in addition to added mileage to their gas bill.


