II.Background and Summary

- A) Brief description of applicant's background:
 - a. Founded in 2018, the Marty & Mickey Kao Foundation's mission is to empower primarily disadvantaged and public school children to reach their full potential through personal development and education. The foundation provides funding and logistical support to public schools and develops community programs and activities in partnership with local school administrators and educators.
- B) The Goals and objectives related to the request:
 - a. The Marty & Mickey Kao Foundation is collaborating with Noelani Elementary School, a local Hawaii State public school in Manoa, and Noelani's PTA to develop the Manoa Recreational Playground Facility for both the Noelani students as well as the larger Honolulu community. At present Noelani does not have a playground with any of the standard playground equipment that all children should have access to. Instead many of the students at the school only have access to an open field during recess with minimal recreational equipment of any kind.
 - b. The Foundation's goal is to build a new recreational playground on what is currently an open field at Noelani School. This new Manoa Recreational Playground would be utilized by both Noelani's elementary students as well as the local Honolulu community as the Noelani field is currently open to the public during non-school hours. A new recreational playground would enable the school to develop new educational programs for students that promote exercise, heath, and fitness.
- C) The Public purpose and need to be served:
 - a. All children need a safe place to play and exercise. Without basic playground equipment the children who go to Noelani School as well as those who live in the larger local community are not having that need met. The new recreational playground would:
 - i. Empower children to lead an active lifestyle and understand the health benefits associated with that.
 - ii. Connect school and home by creating a safe place to meet and play
 - iii. Inspire our children to make physical activity a part of their daily life
 - iv. Encourage cognitive development and imagination

- v. Increase emotional confidence and foster social interaction and cooperation
- vi. Promote moderate and rigorous levels of physical activity that lead to strength, endurance, flexibility, balance, and cardiovascular fitness
- vii. Increase the ability of local children to meet the national P.E. standards.
- b. Worries over obesity and sedentary lifestyles have risen dramatically in recent years and one of the core tenants of the Marty & Mickey Kao Foundation is to promote health and wellness and to motivate children to get active. Playgrounds and play spaces are vital for children. More than a third of American children and teens were obese or overweight in 2012, and childhood obesity has more than doubled in children over the past three decades, according to the CDC. The CDC, pediatricians, the surgeon general and other experts all agree that regular physical exercise can help decrease the number of children struggling with health issues caused by inactivity and obesity.
- c. Hawaii News Now, a local news agency, has recently stated that "obesity rates among young people in the islands are on the rise. They report that according to the National Survey on Children's Health "in Hawaii, 14 percent of those 10 to 17 [are] considered obese. That's up from 11 percent in 2016." This is an alarming trend which requires immediate action or children in the State of Hawaii will suffer the consequences.
- d. A quality playground is a necessity for any school in the country. It is the place where school children can interact best with each other. Their spontaneity reaches its peak on playgrounds as they explore and learn through games and activities. School playgrounds equipped with swings, slides and other playing equipment enable children to harness their coordination and creativity. When children interact with each other in the open and unrestricted atmosphere of a school playground they develop superior communication skills and learn how to form peer relationships. Having a safe place to play can have an immense impact on the children in our communities.
- D) Describe the target population to be served:
 - a. The target population includes the local K-5 elementary school students at Noelani as well as children of all ages in the city of Honolulu as the playground would be open to the public after school hours, in the evenings, and on the weekends.
- E) Describe the Geographic coverage:

a. A new recreational playground at Noelani would have a positive impact on Noelani Elementary School, the Manoa community, and the city of Honolulu.

III. Service Summary and Outcomes

A) Describe the scope of work, tasks, and responsibilities:

The creation of a Manoa Recreational Playground Facility at Noelani Elementary School consists of the following major tasks and sub-tasks:

- 1. Designing the recreational playground:
 - Evaluating the site for the proper location and scale of all playground elements.
 - Interview Hawaii State K-5 educators to assess the style and type of playground equipment that would be best suited for elementary school age children.
 - Create a design plan for the site with selected playground equipment and review with Noelani administrators and educators.
- 2. Engage local vendors to bid on the installation of the recreational playground elements.
- 3. Evaluate and select playground equipment provider.
- 4. Procure all materials and elements for the playground construction.
- 5. Provide logistics support and project management for ordering, transport, storage and installation for all playground equipment as needed with Noelani School and all vendors.
- 6. Provide on-site supervision and support during the equipment installation process.
- 7. Once complete, commission the new recreational playground with Noelani administrators.
- 8. Publicize the event including: opening day ceremony, local press, social media and the Noelani and Marty & Mickey Kao Foundation websites.

 - 1. Planning for the 2020 Manoa Recreational Playground
 - a. 1st Quarter 2020
 - Initial planning, prospective site visits
 - Interview local educators and generate the recreational playground design
 - Evaluate and select a provider for all materials and playground elements
 - Evaluate and select a local vendor for installation work
 - b. 2nd Quarter 2020
 - Order all playground materials
 - Continued planning with local support
 - c. 3rd Quarter 2020
 - Continued refinement and planning
 - Consultation with installing vendor
 - Increase PR efforts in advance of the recreational playground opening
 - d. 4th Quarter 2020
 - Installation of Manoa Recreational Playground at Noelani
 - Finalization of outstanding support issues
 - Heightened PR and local publicity
 - Final site and playground commissioning with educators

- Opening day ceremony
- Ongoing post event publicity and review

 - Each step of the process will be closely monitored by an Oversight Committee consisting of representatives from the Marty & Mickey Kao Foundation, Noelani School Administrators, K-5 educators, and a local 3rd party construction expert. We will develop a detailed timeline and tasks matrix with regular status meetings and calls to ensure timeliness and progress. The Marty & Mickey Kao Foundation's experience with working on past public school construction and installation projects will be vital in delivering a quality and timely outcome on this Manoa Recreational Playground project.

Several of the programs that the Foundation has spear-headed at K-5 schools include:

- AC System Installation in hundreds of classrooms and administrative buildings
- Advanced AV System Installations for Auditorium Multi-Media presentations
- Computer and Tablet Information Technology System Installation
- School Wide PA and Microphone System Installation
- Installation of Custom Window Treatments for Environmental & Noise Control
- School Beautification Projects

In addition, collaborators at Noelani Elementary School will be highly involved with the design and execution of this new Manoa Recreational Playground. Noelani School's administrators and educators have decades of experience with both child development and the implementation of other playground facilities. These professionals have been dedicated to the education and development of children since the school's founding in 1962 and Noelani is a recipient of the 2016 National Blue Ribbon Award for academic excellence.
