Brief Description of Request

The Maui Interscholastic League (the "MIL") filed its Articles of Incorporation with the State of Hawaii Department of Commerce and Consumer Affairs on September 28, 2000, becoming non-profit corporation organized under the laws of the State of Hawaii. The MIL is in the process of preparing its Application for Recognition of Exemption Under Section 501(c)(3) of the Internal Revenue Code. The intention and motivation is to be consistent with other leagues in the State and to be formalized and compliant with all applicable laws.

Since forming as a non-profit in 2000, the Principals and Athletic Directors of each of the public schools on Maui have given of their time and gathered regularly, referring to themselves collectively as the *MIL* dedicating themselves to the student-athlete and scheduling and promoting fair and healthy competitions in high school athletics. The MIL has been overseen, managed and operated by an Executive Director and one staff member. All individuals who have been members and participating in the *MIL* have been State of Hawaii, Department of Education ("*DOE*") employees.

The *MIL* remains steadfast and committed to the mission of the student-athlete, and to promote fair and healthy competition in and amongst the public high schools on Maui. It seeks financial assistance in transitioning to becoming autonomous.

The \$155,308 being sought by the *MIL* is comprised of \$135,308, which will be for the annual salary of an Executive Director and one staff member, and \$20,000 for accounting and legal fees in setting up the entity, obtaining tax exempt status, and implementing governing documents and accounting policies and procedures.

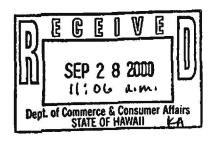

ARTICLES OF INCORPORATION

The undersigned, who is a resident of the State of Hawaii, desiring to form a nonprofit corporation under the laws of the State of Hawaii, hereby certifies as follows:

ARTICLE I Corporate Name

The name of the Corporation shall be Maui Interscholastic League (MIL).

ARTICLE II Corporate Location

The place of the principal office of the Corporation shall be 54 High Street, 4th Floor, Wailuku, Hawaii 96793.

ARTICLE III Duration

The duration of the Corporation shall be perpetual.

ARTICLE IV Corporate Purpose

The objectives of the Maui Interscholastic League (MIL) shall be to:

- (i) promote unity and cooperation on the part of all member high schools in the establishment and administration of policies and regulations for carrying on an interscholastic program of athletics;
- (ii) support athletics as an integral part of the highschool education program;
- (iii) foster amateur sports competition; and
- (iv) operate exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, as amended.

The Corporation is not formed for pecuniary or financial gain on its own account; the Corporation will not issue any stock; and no part of the assets, income or profit of the Corporation is distributable to, or inures to the benefit of the directors, officers or any individual or organization (except for services actually rendered to the Corporation and distributions in furtherance of the purposes stated above) and no substantial part of its activities shall be or is carrying on of propaganda or otherwise attempting to influence legislation.

The Corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on by (a) an organization exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) any organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE V Initial Directors

There shall be a board of directors consisting of not less than 3 members, at least one of whom shall be a resident of the State of Hawaii. The directors (and alternate directors and/or substitute directors, if any) shall be appointed; may be removed from office; and all vacancies in the office of the director or of any officer shall be filled all in the manner provided for in the Bylaws. The following persons shall be the initial directors, and shall hold office for the term stated in the by-laws or until their successors are duly elected pursuant to the by-laws of the Corporation.

ARTICLE VII Corporate Powers

The Corporation shall have all the powers provided by Section 415B-5 of the Hawaii Revised Statutes, as amended, as fully as though set out herein, and in and by said corporate name, to sue and be sued; to make and use a corporate seal and alter the same at its pleasure; to make and adopt and from time to time amend or repeal by-laws not inconsistent with law or with this Articles governing the qualifications, admission, suspension and expulsion of all of its directors, and the voting and other rights, privileges and obligations of directors, and governing the election, government and removal of its directors and officers and the management of its property and affairs; to hold, purchase, take on lease, or otherwise acquire without limit as to amount, and to lease, use, exchange, and (for cash or any other consideration) convey and dispose of such property as the purposes of the Corporation shall require; to borrow money or otherwise incur indebtedness with or without security and to secure any indebtedness by deed of trust, mortgage, pledge, hypothecation or other lien upon all or any part of the real or personal property of the Corporation and to execute contracts, agreements, undertakings, bonds, promissory notes, bills of exchange, and debentures or other obligations or evidences of indebtedness of all kinds whether secured or unsecured.

ARTICLE VIII Members; Service Of Process

The Corporation shall have members, as determined in accordance with the Bylaws. Notice of any process against the Corporation may be given to or served upon any of its principal officers.

ARTICLE IX Indemnity

The Corporation shall have the power to indemnify each present, former and future officer and director, employee or agent of the Corporation in the manner provided in Section 415B-6, Hawaii Revised Statutes, as amended.

ARTICLE X Corporate Liability

The property of the Corporation shall alone be liable in law for the payment of the debts and liabilities of the Corporation.

ARTICLE XI Corporate Dissolution

If the Corporation shall cease to exist or shall be dissolved, all property and assets of the Corporation of every kind, after payment of its just debts and liabilities, shall be distributed only to one or more public agencies, corporations, trusts or foundations having like purposes and organized and operated exclusively for charitable purposes, no part of whose assets, income or earnings may be used for dividends or otherwise withdrawn or distributed to or inure to the benefit of any private director or individual and no part of the activities of which is to carry on propaganda or otherwise attempt to influence legislation. In no event shall distribution be made to any organization unless it qualifies as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986 (or any future successor provision) with purposes similar or related to those of the Corporation.

ARTICLE XII Bylaws

Bylaws shall be adopted by the Board of Directors of the Corporation within 60 days after the adoption of such Articles and may be amended or repealed at any meeting of the directors at which a quorum is present by the vote of a two-thirds (2/3) majority of the directors present at the meeting, provided the notice of such meeting shall have stated that a purpose of the meeting is to consider the amendment or repeal of the by-laws.

ARTICLE XIII Amendments

These Articles may be amended from time to time by a two-thirds (2/3) majority vote of the directors at any meeting of the directors at which a quorum is present, provided the notice of such meeting shall have stated that a purpose of the meeting is to consider the amendment of the Articles.
