II. Background and Summary

1. A brief description of the applicant's background;

Mouna Arts and Cultural Village (MACV) is a 501(c)(3) non profit founded in 2019 and dedicated to providing education in arts, culture, and agriculture. The foundation primarily serves Waianae Coast children and their Ohana.

Mission: MACV is a place of learning and discovery of Mouna (Inner Silence). We seek to find that inner silence which reveals the human heart of love for our selves and all others.

MACV provides a space and opportunity for Hawaii youth to learn and engage in the arts. Some 300 students come to MACV each year to participate in activities. One of the goals of MACV is to provide young artists with disabilities with a space, resources, and opportunity to hone their craft to create a career in the arts.

2. The goals and objectives related to the request;

The goal of the Kohola Ola, Whale That Gives Life project is to work together with the greater Hawaii community and the world in an effort to bring Aloha, unity, peace, harmony, compassion and healing through art.

The project objective is to bring to life the world's largest mother and child whale sculpture, hand made of copper. To create this art, more than 2,000 students, parents, religious and community leaders will come together to transform this dream into reality. The sculpture will include a mother and her "keiki" or child. The mother will be approximately 45 feet long and her keiki about 32 feet. The mother and child motif is significant as it demonstrates unconditional love, care, trust, and peace from generation to generation. As Sooriyakumar, the artist, reminds us, these qualities are urgently needed at this critical time on Earth.

A second objective is to document the project for posterity through: 1. a video production documenting the community working together to create the whale sculpture, 2. a photographic book documenting the making of the sculpture, and 3. a children's book about whales and the community working together to create the whale sculpture.

3. The public purpose and need to be served;

The purpose of the Kohola Ola, Whale That Gives Life project is to work together with the greater Hawaii community and the world in an effort to bring Aloha, unity, peace, harmony, compassion and healing through art. The project will create the world's largest whale sculpture brought to life by the hands of Waianae Coast children with the support of the greater Hawaii community, inspiring our interconnectedness and exemplifying the Aloha spirit of Hawaii while fostering humanity's cooperative nature.

The first need to be served is that although arts education is an essential part of learning; arts education in U.S. schools is declining. The Kohola Ola Whale project will provide over 2,000 Waianae Coast K-12 students and community members with an opportunity to engage in a hands on professional art project led by renowned artist Sooriyakumar.

A second need to be served is although Whales are an essential part of a healthy diverse ecosystem, many Whale populations are endangered. This project provides an opportunity for the Oahu community to learn and appreciate the historical, cultural and environmental importance of Whales to Hawaii's people, culture and ecosystem.

4. Describe the target population to be served; and

The target population is the residence and visitors of Oahu.

5. Describe the geographic coverage.

The geographic coverage is the entire Island of Oahu.

III. Service Summary and Outcomes

The scope of work includes the design and construction of the world's largest whale sculpture made of copper, the recording and production of a video documentary of the project, the creation of a book documenting the project, and a children's book about the community working together to make the whales.

All art from conception to installation are overseen and directed by world-renowned artist Sooriyakumar. To create this art, more than 2,000 students, parents, religious and community leaders will come together to transform this dream into reality. The sculpture will include a mother and her "keiki" or child. The mother will be approximately 45 feet long and her keiki about 32 feet. The mother and child motif is significant as it demonstrates unconditional love, care, trust, and peace from generation to generation.

Each week, groups from different walks of life will come to Mouna Arts and Cultural Village to work on the copper whales in celebration and respect of each others diversity and culture. When we create art, our eyes are opened to seeing beauty. We then can feel the gratitude and connection from nature to ourselves. When we feel this connection, we feel our Ohana, our Family among all people.

The project is led by MACV volunteers. Hawaiian protocols are guided by Native Hawaiian Cultural Adviser, Kahu Kamaki Kanahele. Community field coordination is under Sonia Fabrigas.

April 30, 2020: Completion of installation of the whales and a blessing celebration.

V. Experience and Capability

1. Necessary Skills and Experience

The Kohola Ola, Whale That Gives Life project is overseen and directed by world-renowned copper artist, Muthukumaru Sooriyakumar, Founder of the Mouna Arts and Cultural Village. As resident artist for the Waianae Coast Comprehensive Health Center, Sooriya's sculptures are displayed on all the buildings and the grounds of the facility. Over the past 50 years Sooriya has developed artwork that adorn the entrances and walls of healing centers, temples, homes, and community buildings around the world. His work celebrates the nature and the heart, Oneness and Compassion – universal themes that speak to people of all faiths. His artwork can be seen in countries from Australia and New Zealand to Japan, India and Sri Lanka to Germany and through North America.

2. Facilities

The Mouna Arts & Cultural Village site has a workshop, tools, and ample space for Sooriya to create his sculptures.

The video and books are being produced by outside organizations.

VI. Personnel: Project Organization and Staffing

1. Proposed Staffing, Staff Qualifications, Supervision and Training

Muthukumaru Sooriyakumar, the founder of Mouna Arts and Cultural Village has been working and making copper art in Waianae for 35 years. He is currently the resident artist for the Waianae Coast Comprehensive Health Center, where his copper sculptures grace the walls of the buildings and are installed on the facitiy's grounds. Over the past 50 years Sooriya has developed artwork that adorn the entrances and walls of healing centers, temples, homes, and community buildings around the world. His work celebrates the nature and the heart, Oneness and Compassion – universal themes that speak to people of all faiths. His artwork can be seen in countries from Australia and New Zealand to Japan, India and Sri Lanka to Germany and through North America.

Matthew Nagato, a well known documentary film maker in Hawaii will direct and produce a documentary of the Kohola Ola Peace Project. Matthew founded Lumos Media in Honolulu, Hawaii. He is dedicated to producing inspiring, thought-provoking independent films which challenge mainstream thinking. His acclaimed documentaries, "Ola: Health is Everything" and "Ike: Knowledge is Everywhere" have aired throughout the mainland and Hawaii.

Alex Bocchieri is filming and managing cinematography. His special projects include a short documentary currently in film festivals and upcoming films in association with Sooriya and Matthew.

Sonia Fabrigas, Community Field Coordinator, has 40 years experience planning, organizing, and coordinating special vents and activities, and has been providing cultural education and peace education programs at the Mouna Arts and Cultural Village since 2012.

2. Organization Chart

The project is led by Mouna Arts and Cultural Village volunteers.
