Pana'ewa Community Alliance (PCA) is in its sixth (6th) year of practice as a Native Hawaiian nonprofit organization who serves to improve the quality of life in the Pana'ewa region on the Hawaii Island with over one thousand inhabitants living on the homestead of Pana'ewa furthermore PCA also serves the greater Waiakea Region of the Hawaii Island for provisions concerning the public and its citizens.

2. The goals and objectives related to the request;

Our community set forth initial goals at the project inception and refined this overtime as the planning for Project Kamoleao evolved. We sought to address the Pana'ewa community needs and desires now and in the future, and were endorsed by Pana'ewa Hawaiian Home Land Community Association (PHHLCA) and PCA. The vision as a focal point for Homesteaders was and continues today is health services, community gatherings, educational success, economic self-sufficiency, and cultural regeneration in Pana'ewa.

The essential expansion with our programs has outgrown our temporary site in Pana'ewa Park therefore PCA/PHHLCA has captured a 50-year licensing for 12.77 acreage to build such facilities for our community and the community-at-large to thrive. Our goals are to establish and continue from the initial plan of a successful Master Plan and an approved EIS to increase our Educational-programs, an Aggregate Center for our Children and Kupuna's wellbeing to nurture, and a Health Facility as a request by our community members for easy access to the homesteader and to the community-at-large but most of all for the provisional promise to citizens as indicated by the Hawaiian Home Commission Act on Kamoleao site.

Past funding provided by Legislative Grant in Aid were received in 2016 (\$150,000 to cover the planning, designing, and grubbing on licensed lands for 2 acres) but we are at the phase of Infrastructural composition(s) like continued permitting, electrical, water, sewer layouts, placement, and installation to their assigned site subsequently moving to building a community predetermine facilities.

3. The public purpose and need to be served;

PCA's mission is to enhance the well-being of Native Hawaiians through education, through cultural identity, through programs that nurture, strengthening our youth and their families, and institute a much-needed healthy provisions through educational altered lifestyle, through construct of a clinical facility, and a conceptual medical staffing to meet the need of our communities. Native Hawaiians has been struggling personally in education, a healthy lifestyle, and cultural identity in the islands, PCA's institutionalized mission is to build on the deficit in our communities that seemed wedged by reports of municipal criminalities of sort. Our pledged community programs disentangled these behaviors of such acts with a much-needed expansion of facilities for an adequate space and expansion of these programs to be a success for our community and the community-at-large.

4. Describe the target population to be served; and

The Hawaiian Home Commission Act (HHCA) of 1921 under Section 2(a) 7 ascribes the first people of define in the term of "native Hawaiians" meaning any descendant supplementary of not less than one-half of the blood of the races inhabiting the Hawaiian Islands previous to 1778. Today HHCA paves the way for most destitute and/or economical challenged descendants to date with provision(s) of lease lands to

construct a domicile, to raise crops, to cultivate animal husbandry, and to seek mercantile through charitable design to increase populace awareness in educational growth, and reinvested philanthropical social engineering. However, the challenge with descendants of Hawaii's original Polynesian settlers are in the poorest health than many other Americans. Native Hawaiians tend to suffer asthma, diabetes, and obesity, also and more often to experience severe psychological stress and were likely to say they are in good health. We need a central health and wellness complex for our community to address this overall deficient with Native Hawaiians. The targeted population for this Project is in Pana'ewa and the greater Hilo is Native Hawaiians, who struggles in healthiness, wrestles with monetary stability, and most of all the choices or lack thereof to nutritional values versus stability on income pervasiveness. This embattled group is screaming for help whether unintended or intentional hence our embraced programs are in need of adequate space to flourish.

5. Describe the geographic coverage

Pana'ewa sits in the Waiakea District of South Hilo, Hawaii Island. Pana'ewa community is in the middle of the hub of Hilo with its industrial locations on the perimeter of the homestead, the only mall as its neighbor on East Hawaii, and Major Grocery stores sits on the homestead lands with supplementary local grocery stores on the perimeter also schools are not more than a mile from the community. And Kamoleao sits in the middle of the hub as well as its close proximity to the homestead subdivision a five-minute walk as demonstrated in this plot plan.



The entire 12.77 acreage for Project Kamoleao Community-Based Master Plan has produce an EIS and Community-Base Plan on solid design in pursuit with Architect Scott Flemings & Associates with Engineering illustrations and prints.

The board of PCA voted and chartered an Executive Director (ED) to manage, to employ, and to supervise tasks with negotiating architectural design completions, prints, and permits for the build. ED evaluates, assesses, and hires contractors for the build, also the ED's primary tasks is time achievement to the build of Project Kamoleao. The responsibilities set-forth for the ED is to promote and support PCA Board of Directors in accomplishing and completing Phases one (1), two (2) and 3 (three) phases of Project Kamoleao.

This request in this Capital Improvement Program is for the planning, full designing, permitting phases, and initial construction work of Project Kamoleao. While some planning efforts are underway, designing the conceptual planning will begin in the fall **2020**

The scope of task, work, and responsibilities for this GIA request are as follow;

- Designing and Permitting operation for Project Kamoleao to begin infrastructural formation work on 2 acres of 12.77 acres.
- Ground work preparation, ground work grubbing, infrastructure implementation layouts, and foundation production(s) of Project Kamoleao.
- Prepare plot plan initiatives, layouts, and construct designed structure.
- Attorney and CPA enlistment and consultation with "the Engagement" for PCA/PHHLCA.
- Insurance and land liability proposed coverage for Project Kamoleao.

PCA commits to follow all federal, state, and county laws as well as to secure all necessary approvals including Hawaiian Homes Commission and Department Hawaiian Home Lands.




