The Arc in Hawaii requests \$70,000 for the public purpose of providing wheelchair accessible bathrooms for individuals with intellectual and/or developmental disabilities (ID/DD).

## II. Background and Summary

#### 1. A brief description of the applicant's background

The Arc in Hawaii was founded in 1954 by parents of children with intellectual and/or developmental disabilities (ID/DD). A private 501 (c) (3) non-profit corporation, we are the Hawaii State Chapter of The Arc of the United States. In the early 1990s, we were instrumental in closing down our State's institution, because we believed that individuals with ID/DD should have the right to live, work and play in their communities. We partnered with several entities, including the City and County of Honolulu and Housing and Urban Development to build small community based homes across the island of Oahu. When Waimano Training School and Hospital was closed, many of the individuals moved into our community based homes. Several are still residing with us today. Currently, we operate three adult day health programs, seventeen community based homes and 4 apartment complexes across the island of Oahu. We also provide advocacy and transportation services relieving The Handi-van of a percentage of their ridership. We serve more than 190 adults with ID/DD and their families on Oahu. Our facilities and programs ensure safe, meaningful and dignified integration of our participants into the community. The Arc in Hawaii has worked diligently to employ qualified professional administrative and program specialists that work directly with participants and their circles of support to design individualized support, assistance, and level of care so that they may live their best life.

## 2. The goals and objectives related to the request

It is the mission of The Arc in Hawaii to provide services for people with intellectual and developmental disabilities (ID/DD) on Oahu. The Arc in Hawaii promotes and protects the rights of people with ID/DD and actively supports their right to be included and fully participate in the community throughout their lifetime. To accomplish this mission, The Arc in Hawaii has worked tirelessly to adapt to the changing needs of our participants and to maintain their current living situations. We have 17 group homes and 3 Adult Day Health programs that are all aging and need renovation on various levels. We desperately need to renovate the accessible bathrooms in our Wahiawa homes (2) and our women's restroom located at our Honolulu Center Adult Day Health Program. We currently have 8 individuals with ID/DD living in our Wahiawa homes and we have 56 individuals that attend our Adult Day Health Program in Honolulu. Our current women's restroom is in dire need of renovation. Because our participants are aging, we need larger stalls so that wheelchairs and walkers can obtain proper access. The goal is to address our aging population and adapt to their changing needs. (We have already renovated our men's restroom)

## 3. The public purpose and need to be served

Many island families choose to keep their adult children with ID/DD with them for as long as possible and they serve as their primary care givers. But as these individuals age and their supportive needs increase, and as family members age themselves, many are unable to provide the level of care needed. Our residential program provides professionally trained staff that provide the most appropriate care for these individuals. This project will help to ensure that our homes are maintained, safe, functional and accessible for years to come. This project will also allow our women of our adult day health program to have proper access to restroom facilities. We also make our Honolulu ADH hall available free of charge to groups with ID/DD like the Self Advocacy Advisory Council. This restroom would provide proper access for them. (Note: We were able to renovate our men's restroom approximately three years ago)

The accessible women's bathroom will enable our staff to better assist our participants in wheelchairs and walkers. Christie is a 3 1/2 year employee with The Arc in Hawaii and she makes the following statement:

When toileting clients, it is very difficult to toilet clients with wheelchalts or walkers because on the space is very limited. The smaller stall has a limiter toilet so clients have a hard time sitting on it and getting back up.

## 4. Describe the target population to be served

The 8 residents of these two homes will benefit directly from the proposed project, but the as resident's needs change, The Arc will see discharges, so over time, this project will benefit so many more individuals. Our ADH program restroom will benefit our current participants, those that attend our facility for meetings and our future participants.

The accessible women's bathroom will enable our female participants to obtain easier access. Deborah is an older adult with disabilities. She cannot write well herself because of the shakiness in her hands. She made the following statement and staff wrote for her.

I get a hard time getting into the bathroom. I want it bigger for my walker. I have to hold the door open to get my walker in. I get wet when washing my hands. The sink is too low

## 5. Describe the geographical coverage

The Arc in Hawaii provides a range of services throughout the island of Oahu. We have homes in Ewa Beach, Waipahu, Wahiawa, Halawa, Kaimuki, Lusitana and Hawaii Kai. We also have day programs in Wahiawa, Pearl City and Diamond Head. This particular project will serve both the Wahiawa area and the Diamond Head area.

## **III. Service Summary and Outcomes**

## 1. Describe the scope of work, tasks and responsibilities

The proposed project will involve the construction of new wheelchair accessible restrooms/showers. Initial cost estimates have been received by a licensed contractor in the State of Hawaii. The project will be completed by qualified contractors selected through a competitive procurement process with supervision from our Facilities Manager. Our Facilities Manager (FM) will ensure that the project is

scheduled and completed satisfactorily. He will approve invoices and change orders if applicable, oversee the projects and conduct a final inspection. The Arc in Hawaii's fiscal staff will work with the Facilities Manager to coordinate all record-keeping, accounting and reporting functions to ensure compliance. The Executive Director will be involved in contractor selection, concept design and grant reporting and compliance.

2. Provide a projected annual timeline for accomplishing the results or outcomes of the service:

This proposed project is estimated to be completed over a two-month period of time. Once The Arc in Hawaii secures funding, we will obtain bids for the project. The FM will meet with the Executive Director to discuss bids and a contractor will be selected. We will select a mutually agreeable date to start the project. The FM will work closely with the contractor to ensure a timely completion.

3. <u>Describe its quality assurance and evaluation plans for the request. Specify how the applicant plans to monitor, evaluate, and improve their results:</u>

The Arc in Hawaii's FM will manage all aspects of this project. The objective of a competitive bidding process is to select a properly licensed, qualified contractor that will complete the project in a professional manner at the most competitive cost. The new roof is not a complicated project.

## V. Experience and Capability

## 1. Necessary Skills and Experience

The Arc in Hawaii was founded in 1954 by parents of children with intellectual and/or developmental disabilities (ID/DD). A private 501 (c) (3) non-profit corporation, we are the Hawaii State Chapter of The Arc of the United States. In the early 1990s, we were instrumental in closing down our State's institution, because we believed that individuals with ID/DD should have the right to live, work and play in their communities. We partnered with several entities, including the City and County of Honolulu and Housing and Urban Development to build small community based homes across the island of Oahu. When Waimano Training School and Hospital was closed, many of the individuals moved into our community based homes. Several are still residing with us today. We currently provide the following:

- 1) 17 Residential Group Homes that are licensed by the State of Hawaii Department of Health. All of our homes are staffed with live-in resident managers and Arc trained staff. Staffing is based on the specific license/needs of the residents.
- 2) 4 Apartment Complexes (48 units) designed for the higher functioning individuals who need minimal supervision. These individuals live in their own one bedroom apartments and are provided with support from their resident manager, based on their individual needs.
- 3) DD Waiver Services- Services including Adult Day Health and Community Learning Services-both group and individual;
- 4) Transportation Services- Currently The Arc in Hawaii operates a fleet of 34 vehicles, which include 15 lift vans with wheelchair capacity.

The Arc in Hawaii is the largest residential provider for Individuals with ID/DD in the State of Hawaii. We are one of our industry's leaders here in the State as well. It is our goal to continue to provide safe, well-maintained living/learning environments for our residents/participants.

#### 2. Facilities

In addition to our 17 residential group homes across the island of Oahu, we have 3 day health programs and 4 apartment complexes. We also have a maintenance shop and our administrative offices at Diamond Head.

Our 17 homes are located in Ewa Beach, Wahiawa, Waipahu, Halawa, Lusitana, Kaimuki and Kamehame Ridge.

maintenance/upgrades. He works closely with HUD on our annual inspections for all of our HUD properties and he is an integral part of The Arc in Hawaii's Executive Management team.

The Arc in Hawaii's Executive Director (Lei Fountain) is responsible for managing all aspects of the organization's operation in addition to fundraising and community outreach. Lei Fountain has over 24 years of Executive level management in the State of Hawaii. Over 16 years of her experience was spent in Hawaii's travel industry in revenue management, contracting/negotiations, customer service, operations and sales. She has her BS in Accounting and her Master's in Business Administration.

We work closely with representatives of DOH-DD Division, Medicaid and HUD to ensure compliance with all requirements. As such, we anticipate the funding from these sources will continue. The funds requested in this proposal will be used for a one time improvement. This proposed project will ensure that these homes provide proper accessibility for our residents/participants and guests. It will also ensure that our homes and ADH centers are available for the future needs of Hawaii's intellectually/developmentally disabled adults.
