
1. A brief description of the applicant's background;

The Hawai'i Good Food Alliance is a diverse hui of people who share in the production, aggregation and distribution of food to re-build thriving community food systems. We join together—with a sense of urgency—to raise community voice and support one another in the belief that each and every person in Hawai'i can share in healthy, locally produced food.



The group started in 2016, convening food systems leaders across all Hawai'i counties, and currently includes members from:

The Alliance includes farmers, emergency food relief, health clinics, and other food systems nonprofits across all counties. In 2019, Alliance organizations reached 110,744 consumers to supply local, good food and inspired 85,532 volunteer hours. Those efforts are supporting 366 local farms and getting local food to 327 local institutions and retail outlets. The Alliance's approach is to restore the ability of communities to produce, distribute, and consume their own food that connects people to land and each other.

In this grant opportunity, The Hawai'i Good Food Alliance is being fiscally sponsored by The Food Basket.

#### 2. The goals and objectives related to the request;

The goal of this request is to center, and reconnect, culture into Hawaii's local food movement and grow the local food economy. As part of that overall goal, we are pursuing two objectives:

 Convene 13 food systems leaders from across the state in 4 quarterly meetings; and  Produce a series of 4 short videos, social media posts, and other local food marketing communications as part of a campaign to eat local, eat healthy, and reconnect to your culture.

#### 3. The public purpose and need to be served;

We know local food production and eating local has economic value--creating jobs, and building a more resilient agricultural economy. The State recognizes a thriving local agriculture economy as critical, yet there is more work to do to make this vision a reality.

People want to grow more of their own food, and they want to eat more local food. Yet, a lot of the local food movement components (e.g., growing, sharing, and enjoying food) are disconnected--from each other, and from the diverse cultures of Hawaii. The Alliance is solving for a set of problems facing the local food movement:

Problem	Public Purpose
Organizations in the local food movement are not connected with each other	Increase collaboration and efficient uses of resources
People don't connect culture and local eating	Healthy eating and social cohesion improve health
Not enough farmers are not able to earn a living wage	Creating a thriving local agricultural economy

HGFA will expand the ability for people to grow food, and will promote the benefits of local, healthy eating. BUT, there is growing evidence that culture, and how it connects us to each other and to our land is what will drive healthier people and a stronger economy (see figure below). When we are connected, we are seeing reduced health risks, improved graduation rates, and a stronger local agriculture economy.

The Alliance implements an annual membership survey with the University of Hawaii Cooperative Extension. We will conduct that survey again in late 2020 and 2021 to monitor collective impact of the Alliance on factors such as:

- · Communication and community engagement reach; and
- Organization sustainability (e.g., paid FTE, volunteer hours, earned income).

The Alliance will also use some of the time spent on evaluation to explore ways to better monitor, quantify, and communicate the collective impact in the food system relative to health, economic, and environmental outcomes.

The Alliance's 13 members have been building a local food movement, on average, for more than 27 years. There are few groupings of leaders positioned to strongly advance all aspects of increasing local food production and healthy eating.

Alliance leaders provide direct services and have innovated in the areas of: food systems internships/apprenticeships, farmer's markets, youth leadership development, food aggregation, SNAP access, and Agriculture Education (preschool to professional development).

In the last three years, some of the most pertinent projects and contracts include:

- 1. Establishment of the Hawai'i Good Food Alliance
  - a. First statewide alliance of organizations rebuilding local systems
- 2. Double Up Food Bucks
  - a. Secured \$2M in funding from federal, state, and private partners that allows low income families to access local fruits and vegetables at half the market price.
- 3. Hawai'i Farmer's Market Association
  - a. First statewide association for all farmer's markets to identify needs, strengthen connection with local farmers, accept SNAP/EBT and offer Double Bucks, have a national voice, and provide the collective support for markets to thrive.

#### 2. Facilities

For this project, there is no need for direct use of facilities. The project is about leveraging networks of organizations within the food systems (and their existing facilities), and growing the community engagement/communications to promote healthy eating. We rent facilities as needed, and they are often provided by membership as in-kind commitments to the organization and its work.

## VI. Personnel: Project Organization and Staffing

#### 1. Proposed Staffing, Staff Qualifications, Supervision and Training

The project will be staffed by the Alliance's founder and program lead--Tina Tamai, a Robert Wood Johnson Foundation Culture of Health Leader. Tina will be responsible for overall project management, coordination, and strategy including planning convenings and overseeing all deliverables. Tina Tamai founded the Hawaii Good Food Alliance while working at the Hawaii Dept. of Health. In collaboration with

Alliance members, the Alliance became an independent state-wide community coalition. She is a Robert Wood Johnson Foundation Culture of Health Leaders Fellow. She has a diverse background which includes development of programs around Tobacco Cessation ,Youth Access Prevention, and Merchant Education, in addition to the establishment and start-up of the Hawaii Tobacco Quitline. She developed and established the USDA SNAP Education program which led to the creation of the Alliance. She holds a BS in Dental Hygiene from USC, a Masters in Public Health from UC Berkeley, and a Juris Doctorate from UCLA.

Kristen Foster Albrecht, Executive Director at The Food Basket Inc., will be responsible for all project reporting and fiscal management. Ms. Albrecht develops and evaluates annual work plans in conjunction with the strategic plan of the Board; recommends annual budgets; reports on program results and resource utilization. Ms. Albrecht also prepares and administers agency budget with Board approved guidelines; reports on funds disbursed; coordinates grant preparation and builds and maintains a strong network of relationships in Hawai'i County, the State and nationally to support The Food Basket. Ms. Albrecht was the point person for emergency response and relief food, water and supplies for those affected by the Kilauea Lava Flow and Hurricane Lane.

Monica Esquivel, at University of Hawaii, will lead the effectiveness monitoring for the project and annual surveying of members. Monica Esquivel is an Assistant Professor at University of Hawaii at Manoa in the Department of Human Nutrition, Food and Animal Sciences. She is a Registered Dietitian and earned her doctoral degree in nutrition from University of Hawaii at Manoa. Her research focuses on child health and obesity reduction among minority populations in the US Affiliated Pacific, through multi-level interventions that seek to address social determinants of health.

The Alliance will secure communications contractor to assist with communications strategy, video production, and social media strategy to maximize the number of potential consumers reached to increase local, healthy food consumption.

For this project, the Food Basket Inc. is acting as the fiscal sponsor or lead for the Alliance.
