Public Purpose

Work Now Hawaii verifies that the grant will be used for a public purpose pursuant to Section 42F-102, Hawaii Revised Statutes.

The purpose of the Transition Age Youth Work Experience Program is to provide an introduction to employment for individuals living with disabilities, helping them to assess work readiness.

The details of the cost and budget for the program can be found in sections **IV. Financials** of the grant application.

II. Background and Summary

1. Applicant's Background

Work Now Hawaii is a 501(c)(3) nonprofit organization established in August of 2017 to help people living with disabilities achieve independence through gainful employment. Our unique training programs are designed to maximize individual strengths and abilities in a way that increases confidence and productivity. We identify and provide accommodations our clients may require to be successful throughout their careers.

Over the past three years, we have worked to create jobs for our clients and income for our organization by providing contract services to the State of Hawai'i and several small businesses on O'ahu. These business services include custodial and cleaning, secure document destruction, website development, digital marketing and technical support.

We also run a Transition Age Youth Work Experience Program. Having partnered with the Hawaii School for the Deaf and Blind in the 2018/19 and 2019/20 school years, we have helped students successfully navigate their first professional work experiences. By providing paid internships in the fields of custodial services and digital marketing, students were given the opportunity to explore multiple career paths that fit their interests and abilities, and set a path to earning a livable wage.

In this program, students are taught basic skills, such as accountability, communication, teamwork, problem solving, initiative and enterprise, planning and organizing, and self-management. They are also introduced to specialty skills within their areas of interest, allowing for professional growth and development.

Work Now Hawaii provides free services to individuals with varying disabilities. Our current programs focus on individuals who are Deaf, or who are diagnosed with intellectual or developmental disabilities.

2. Goals and Objectives

This GIA funding request will support the expansion of and sustainability for our Transition Age Youth Work Experience Program.

Program Expansion - While we have had to run either our Custodial Services or Digital Marketing work experience opportunities, we will offer both concurrently, affording students the option to explore either career path. With this expansion, we would serve an additional six (6) students per semester for a total of up to ten (10).

The funding provided will allow us to achieve the following objectives:

- Support the current Executive Director who will ensure fulfillment of the organizations mission by,
 - Creating jobs and achieving the organization's financial sustainability through growth of our service contract work,
 - Making connections with HR professionals representing large employers in our community to facilitate disability inclusion conversations,

- Establishing employment service contracts with the State of Hawaii Department of Human Services, Division of Vocational Rehabilitation, and the Department of Health, Developmental Disabilities Division to offer services for their clients,
- Expand our Benefits Counseling service offering to additional non-profit organizations throughout the islands, helping their clients to navigate the reduction of government benefit while they start employment.
- Recruitment of a Program Manager who will support the Transition Age Youth Work Experience Program by:
 - Connecting with additional Department of Education Transition Coordinators to identify students with interests and abilities that match our opportunities,
 - Assisting students in the program with their training, coaching, and employment support services,
 - Monitoring and surveying measures of success, including performance evaluation plans, and goals of successful employment offers
 - Identifying additional career paths of interest for future expansion phases
- The purchase a motor vehicle for use in transporting custodial teams, equipment and supplies
 - Enabling us to grow our team's operating capacity to sequentially service multiple buildings
 - Helping to overcome transportation barriers for our clients
- The purchase of four (4) laptop computers to be used for work on digital marketing and administrative tasks
 - Students are taught foundationary computer skills which would be required in most jobs today including email, spreadsheet and word processing, and internet searching and navigation
 - Computer and internet technology provides access to tools and resources to perform administrative and digital marketing tasks
 - Web based tools are used to build digital resumes, fill out employment applications, and build business network connections

Our objective is to expand upon the opportunities transition age youth living with disabilities may face, and help them to adapt to and overcome barriers they may face to competitive employment. This fulfils our mission of helping them achieve independence through gainful employment.


3. Public Purpose

Employment provides many benefits, including creating economic self-sufficiency, social networks and a sense of self-worth. However, for far too many individuals living with disabilities, the benefits of work are still out of reach. The purpose of our Transition Age Youth Work Experience Program is to introduce employment to high school age students who are living with disabilities, helping them to overcome initial barriers to competitive employment. We have served three to four students per semester in the 2018/19 and 2019/20 school years.

4. Target Population

The target population for our program are youth from 16-24 who are in their junior year, senior year, or who have recently graduated from high school, and who currently receive support through the Department of Human Services, Division of Vocational Rehabilitation, or the Department of Health, Developmental Disabilities Division. We also serve members of the gap group, people living with disabilities that have not qualified for services. There are no limits to sex, gendor, race or socioeconomic status, as well as geographic location. Preference is given to residence of Hawaii.

From 2017-2019, the population we have served is broken down as follows:



5. Geographic Coverage

Work Now Hawaii currently serves clients from diverse geographic regions of Hawaii, including residents of Oahu and our neighbor islands.

III. Service Summary and Outcomes

1. Scope of Work, Tasks and Responsibilities

The scope of work will follow the past performance of the program. Work Now Hawaii will provide paid internships to transition age youth in their fields of interest.

The Program Manager will coordinate employment and act as the direct supervisor and work site mentor.

- Preparations are made with the School-Site Coordinator to identify potential students for the program.
- Interviews are conducted to assess the student's interests and abilities.
- Training Agreement of Exception for Hawaii Work-Based Learning Experience is executed by Work Now Hawaii, the School-Site Coordinator, the Student and their parent or guardian.
 - All State and Federal regulations apply to Work-Based Learning programs. In addition, the Employer agrees to permit the School to perform a safe working environment survey of the premises.
 - The Employer has a safety and health program as required by ACT 242, SLH 2001; will ensure that the Student receives specific instruction on the recognition of possible hazards in the nature of the workplace; and the Mentor and co-workers at the work site have received instruction on safety and health precautions, safeguards, and limitations of student work activities particularly with regard to child labor laws and safety rules of the work site.
 - Work Now Hawaii will assign the Student work.
 - Work Now Hawaii will assign a Work Site Mentor to the Student.
- Post hire questionnaires are collected to assess the students' work readiness.
- A performance plan is put in place to ensure measurable progress is made throughout the semester.
- Employment services, including Social Security and government benefits planning, resume building and job search is offered to assist with securing employment.
- An end of semester review and questionnaire is conducted to evaluate the program's effectiveness.

The Executive Director will

- Work to achieve sustainability and job creation through growth of our service contract work,
- Assist with measurability and reporting of the program,
- Maintain business operations including payroll, bookkeeping, finances and regulatory reporting,
- Maintain qualifications and program requirements for Work Now Hawaii.

V. Experience and Capability

1. Necessary Skills and Experience

Patrick Gartside began as the founding Executive Director for Work Now Hawaii and has been working closely with other community non-profit organizations, State and Federal agencies, and institutional education systems to identify the organization's role and capacity to help provide employment for individuals living with disabilities.

In an effort to create jobs, Patrick has put together bid proposals which have resulted in successfully awarded contracts to Work Now Hawaii. These contracts with the State of Hawaii and in private industry are providing custodial and web development service jobs for individuals living with disabilities. Patrick is also providing on the job training, job coaching and employment support for these Work Now Hawaii employees. Work Now Hawaii is recognized as a Qualified Community Rehabilitation Program, and will be seeking more State and Federal service contracts to provide jobs, all which come with the coaching and support needed for successful employment.

Patrick has provided job placement for people living with disabilities, including both training and support for the individual and the employer. He has helped to facilitate Disability:IN Hawaii, a business network initiative which works to educate and support on topics of disability at work.

Successful proof of concept has been achieved with our Transition Age Youth Work Experience Program. In the 2018/19 and 2019/20 school year, Work Now Hawaii provided a school-based career exploration program for students of the Hawaii School for the Deaf and Blind. Individuals in the program were provided jobs and trained in the field of custodial service and digital marketing. Patrick provided coaching support, as well as tools to help them adapt to working with their disability. Training was also provided to non-disabled individuals in the workplace, helping them to work effectively together.

Verifiable Experience

Hawaii School for the Deaf and Blind Work Experience Program - For the 2018 / 2019 and 2019 / 2020 school years, Work Now Hawaii provided work for transition age youth in the fields of custodial services and digital marketing.

With funding through the Department of Health, Developmental Disabilities Division, Patrick has become a certified Benefits and Work Incentive Practitioner, and provides Social Security benefits planning services. He has helped individuals navigate their government benefits and take a critical first step in exploring paths to employment. Patrick is providing this service for Work Now Hawaii employees as well as for clients of Goodwill Hawaii.

Work Now Hawaii is also currently contracting with the State of Hawaii:

Dept. of Business, Economic Development and Tourism - We provide custodial services for the Foreign Trade Zone, a contract in which we employ and support individuals living with disabilities. We have entered into our second option year of service.

Work Now Hawaii Grants in Aid Application FY 2021

Dept. of Health, EMS Injury Prevention Systems Branch - We provide web development services and support for the branch, a contract in which we employ individuals living with disabilities.

2. Facilities

Work Now Hawaii operates out of Impact Hub Honolulu, a coworking, event, office, and community space designed to facilitate sustainable impact in Hawaii and abroad through collaboration and empowering communities.

This inclusive work environment helps to prepare our clients for the workforce and opens up opportunities through networking and events. Being around working professionals opens up opportunities for employment with other small businesses. We have contracted work with several small businesses allowing us to provide employment opportunities for our clients.

We have two office spaces, including one which is used for training in digital marketing product photography. Our clients utilize this space, as well as the coworking space for their training. We have also hosted several meetings for the Disability:IN business network.


VI. Personnel: Project Organization and Staffing

- Patrick Gartside is a certified Benefits and Work Incentive Practitioner, and provides Social Security benefits planning services. Certification is through Cornell University, K Lisa Yang and Hock E Tan Institute on Employment and Disability, and is valid June 26, 2018 through June 26, 2023

3. Private Educational Institutions

This grant will not be used to support of benefit a sectarian or non-sectarian private educational institution.

4. Future Sustainability Plan

Work Now Hawaii will utilize the GIA funds to support the Executive Director and Program Manager in their efforts to acquire and successfully perform additional service contract work. The revenue from this work will support their salaries, and to create jobs for our target population of people living with disabilities.

Work Now Hawaii is recognized by the US Dept of Labor and the Hawaii State Department of Labor and Industrial Relations as a Qualified Community Rehabilitation Program. As such, we are able to identify State contracts in the fields of Custodial Services, Landscaping, Digital Marketing, Laundry Services, Office Services, and Packaging Services and enter into contract negotiations.

Work Now Hawaii is also a SourceAmerica affiliated agency, and is working to identify and acquire contracts through the AbilityOne program. This Federal contracting set-aside allows qualified non-profit agencies to hold life long while employing individuals living with disabilities.
