In accordance Section 346-29.5, Hawaii Revised Statutes, the Department of Human Services (DHS) is required to submit an annual report to the Legislature, which shall include a list of liens held by DHS on real property. This report shall include, but not be limited to, a description of the value of the liens, the legal status of the liens and when the liens were initiated.

Attached please find a listing of active home property liens filed by the Department of Attorney General on behalf of DHS. Also attached is a summary report for recoveries made during the period (July 1, 2018 – June 30, 2019). A total of \$ 2,311,477.15 was recovered from 66 cases listed. See Attachment 1.

Also included is a list of liens currently held by the DHS on real property. The total dollar amount of liens totals \$76,038,562.49. See Attachment 2.
