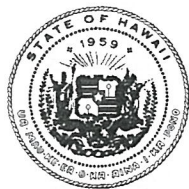

Section 346-51.5, Hawaii Revised Statutes (HRS), requires the Department of Human Services (DHS) prepare a report on the Temporary Assistance for Needy Families (TANF) and Temporary Assistance for Other Needy Families (TAONF) programs that includes:

- 1) A plan for expenditure of TANF funds to include, a) details how the funds received under TANF shall be expended; and b) descriptions of the desired outcomes from the expenditure of the funds; and
- 2) A report about a) the continuing strategic planning process, with the assistance of the Financial Assistance Advisory Council, to involve the community in planning for the future use of TANF funds and setting annual goals and outcomes for existing and new programs receiving TANF; b) on the effectiveness and level of success in reaching the desired outcomes from the previous two fiscal years using TANF funds; and c) on any funds received and expended supplemental to the TANF block grant, the purposes for which the funds were expended; and outcomes achieved.

II. TANF STRATEGIC PLANNING AND LEVEL OF SUCCESS:

A. The Financial Assistance Advisory Council (FAAC)

Council meeting on September 28, 2018

1. Legislative Updates from SLH 2018: The council reviewed Acts 109 and 128.

Act 109 (SB2990) Relating to Family Leave. The Act requires the Legislative Reference Bureau to conduct a sunrise analysis on a paid family leave program and potential impacts to industries, consumers, employees, employers, and care givers. The analysis will include evaluation of other states' paid leave models and cost implications for each model.

Act 128 (HB2204) Relating to Human Services. The Act requires the department to reestablish the exit and retention bonus program, and appropriated \$400,000 for fiscal year 2019 to develop the program.

2. Program Updates:

Executive Order 13828 – Reducing Poverty in America by Promoting Opportunity and Economic Mobility. The council discussed the potential impacts to non-cash assistance programs if work program participation becomes a requirement to receive benefits. Currently, work program participation for TANF recipients is mandatory. However, requiring able-bodied SNAP recipients to participate in a mandatory work program will require significant funding. The State has approximately 40,000 able-bodied SNAP recipients, however, the current funding can only service about 1,500 individuals. Many individuals who receive medical assistance are already participating in some type of work program.

DHS reported on the Benefits Eligibility Solution (BES) project. The department executed a contract with Unisys who is contracted to build the new eligibility system. The new eligibility system will reside on the same platform as the KOLEA system and is projected to complete in 2.5 years.

3. New Business:

DHS reported that the child care subsidies and Preschool Open Doors rates recently increased for all types of care, e.g. facility and home-based.

The State was awarded an 18-month technical assistance (TA) from the National Governors Association. The TA will assist the State in developing strategies to streamline programs and services and to braid funding sources. Participants of this TA includes the department’s Med-QUEST Division (Medicaid); Social Services Division (Child Welfare); Benefit, Employment and Support Services Division (BESSD-TANF); Department of Education; Department of Health; and the Executive Office on Early Learning.

B. TANF Measures of Effectiveness and Level of Success in Reaching Outcomes

The outcomes for the TANF Program, as reflected in the State Budget, are as follows:

1. *Percentage of Households Determined Eligible for TANF Assistance*

FY 2019 Planned = 24%	FY 2020 Planned = 22%
Actual = 22%	

The low employment rate and healthy job market may have been a factor to the number of households determined eligible for TANF assistance in 2019 to be less than the planned outcome level.

Percentage of TANF Recipients in Work Program Exiting Due to Employment

FY 2019 Planned = 12%	FY 2020 Planned = 12%
Actual = 12.5%	

For SFY 2019, the average wage of employed work program participants was \$11.87/hour. Based on 30 employment hours per week, the estimated gross earnings of \$1,424 per month would allow a family of three to be eligible for TANF benefits.

2. *Percentage of TANF Recipients Who Obtained Employment*

FY 2019 Actual = 27% FY 2020 Planned = 27%

Percentage of TANF Households Exited Due to Earnings

FY 2019 Actual = 12% FY 2020 Planned = 12%

3. *Supporting Employment Empowerment (SEE) Hawaii Work Program*

DHS implemented the SEE Program in 2006 to provide on-the-job training and employment opportunities with private sector employers for First-To-Work (FTW) Program participants that may have little or no work experience or basic work skills. Participants employed through the SEE Program may work a minimum of 24 hours per week, for up to six (6) months.

Participating employers set and pay SEE employees' (FTW participants) wages and benefits. The State reimburses the employers 100% of the State's hourly minimum wage. For each additional \$1.00 per hour paid to the SEE employee, the State reimburses the employer \$0.50. The maximum hourly rate paid to the employee that may be subsidized is \$14.00, and the employee may work no more than 40 hours/week. Employers also are reimbursed 14% of the subsidized wages to cover the cost of training and other employment-related costs and overhead expenses. Additionally, the State provides SEE employees supportive service payments such as transportation and child care assistance.

a) *Participants Employed Through the SEE Program:*

SFY 2018 = 128 (unduplicated) FTW participants

SFY 2019 = 45 (unduplicated) FTW participants

b) *Average Work Hours and Wage:*

SFY 2018 = Average of 23 hours/week for an average wage of \$10.40/hour

SFY 2019 = Average of 27 hours/week for an average wage of
\$11.15/hour

c) *Transitioned from Subsidized to Unsubsidized Employment:*

SFY 2018 = 77% transitioned from SEE to unsubsidized employment

SFY 2019 = 43% transitioned from SEE to unsubsidized employment

d) *Businesses Participated with the SEE Program:*

SFY 2018 = 90 SEE employers

SFY 2019 = 44 SEE employers

4. *Work Participation Rates*

The Federal government mandates that States meet two work participation rates as a condition of receiving and expending TANF Federal Block Grant and State Maintenance of Effort (MOE) requirements.

- a) *All-Family Participation Rate of 50%:* Of all TANF recipient cases that have at least one work eligible individual who is complying with their federally mandated work activities.

The 50% compliance rate for the All-Family Rate is the federal baseline before factoring in the caseload reduction credit, the credit to the State for declining assistance caseloads.¹ Hawaii's Caseload Reduction Credit for Federal Fiscal Year (FFY) 2019 is estimated to be 75.1%. The adjusted All-Family work participation requirement to be met is zero percent (50% - 75.1% = 0%).

As of November 2019, 29.31% of mandatory households were meeting the work participation requirements for FFY 2019. Therefore, Hawaii is currently exceeding the required participation, 29.31% compared to zero percent.

Mandatory Households Meeting All-Family Work Participation Requirements

FY 2019 Planned = 50%

Actual = 29.31% (prior to the application of the Caseload Reduction Credit)

FY 2020 Planned = 29% (prior to the application of the Caseload Reduction Credit)

- b) *Two-Parent Participation Rate of 90%:* Of all TANF recipient cases that have two work eligible parents are complying with their federally mandated work activities.

¹ Pursuant to Section 407(b)(3) of the Social Security Act (the Act), the U.S. Department of Health and Human Services (HHS), Administration for Children and Families (ACF), reduces a state's required participation rate for a Federal Fiscal Year (FFY) when the number of percentage points that the average monthly number of families receiving assistance during the year immediately preceding the current fiscal year is less than the average monthly number of families that received assistance during the comparison year (FFY 1995). The statute prohibits this reduction from including any caseload declines due to requirements of Federal law or due to differences in state eligibility criteria. The reduction in the participation rate is referred to as the Caseload Reduction Credit.

The 90% compliance rate for the Two-Parent Rate is the federal baseline before factoring in the Caseload Reduction Credit. The same estimated Caseload Reduction Credit for FFY 2019 of 75.1% can be applied. The adjusted Two-Parent Participation Rate to be met is 14.9% (90% - 75.1% = 14.9%).

As of November 2019, 46.86% of mandatory two-parent households were meeting the work participation requirements for FFY 2019. Therefore, Hawaii is currently exceeding the required participation, 46.86% compared to 14.9%.

Mandatory Households Meeting Two-Parent Families Work Participation Requirements

FY 2019 Planned = 45%

Actual = 46.86% (prior to the application of the caseload reduction credit)

FY 2020 Planned = 44% (prior to the application of the caseload reduction credit)

5. *Supplemental Funding*

In addition to the annual TANF Block Grant, States may be eligible to receive a portion of the TANF Contingency Fund. The TANF Contingency Fund provides funding for States to provide benefits and services to needy families in times of economic downturns. A State may receive 1/12 of 20 percent of its annual block grant for each month that it qualifies as an “eligible State.” If the State qualifies for contingency fund for the full fiscal year, such expenditures are multiplied by the State’s Medicaid match rate to determine the amount that the State may keep. However, if the State is eligible for less than the full year, the match rate is reduced by the fraction of the year that the State qualified as an “eligible State.” Thus, a State may receive up to 20 percent of its TANF Block Grant, if eligible for an entire year.

To qualify for contingency funds, States must spend non-Federal funded Maintenance of Effort (MOE) State dollars at 100% of its pre-TANF Aid to Families with Dependent Children (AFDC) level and meet one of two “needy State” triggers:

1. *High Unemployment Rate:* An unemployment rate for a 3-month period that is at least 6.5 percent and 100 percent of the rate for the corresponding period in either of the two preceding calendar years; or
2. *High Supplemental Nutrition Assistance Program (SNAP) Caseloads:* A SNAP (formerly known as Food Stamps) caseload that is 10 percent over the FY 1994-1995 level (adjusted for the impact of the 1995 welfare reform law’s immigrant and Food Stamp provisions on the Food Stamp caseload).

In FFY 2019, Hawaii qualified to receive \$11,424,664 of the TANF Contingency Fund, however, DHS did not spend the funds. The entire amount will be remitted to the Administration for Children and Families (ACF) because Hawaii was unable to meet the contingency fund MOE requirement. Due to a recent clarification received from ACF, certain MOE expenditures that were previously claimed to meet the TANF Contingency Fund MOE requirement were not allowable. As the result of this clarification, Hawaii would not meet the contingency fund MOE requirement if the funds were expended.

The reserve is established to ensure benefits and supportive services for recipients families and operational costs can be maintained for about twelve months should there be a federal government shutdown or funds are not appropriated by the U.S. Congress.
