RELATING TO CHILD SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 350-2, Hawaii Revised Statutes, is
2 amended by amending subsection (f) to read as follows:

3 "(f) For a confirmed case of child abuse or neglect that
4 occurred [~~where a child is provided care,~~] at a child care
5 facility as defined in section 346-151, that is operating in
6 accordance with an exclusion or exemption pursuant to section
7 346-152 [~~and~~], upon receipt of the proper consent [~~of the child~~
8 ~~care provider~~], the department is authorized to disclose that
9 the report of child abuse or neglect was confirmed to any parent
10 or guardian of a child who was enrolled at the [~~licensed or~~
11 ~~registered~~] child care facility [~~as defined in section 346-~~
12 ~~151~~]."

13 SECTION 3. Statutory material to be repealed is bracketed
14 and stricken. New statutory material is underscored.

JUSTIFICATION SHEET

DEPARTMENT: Human Services

TITLE: A BILL FOR AN ACT RELATING TO CHILD SAFETY.

PURPOSE: To correct section 350-2(f), Hawaii Revised Statutes (HRS), and to clarify that upon proper consent, the department is authorized to disclose a confirmed report of child abuse or neglect has occurred at a child care facility excluded or exempt from part VIII, Child Care, chapter 346, HRS, to any parent or guardian of a child enrolled at that child care facility.

MEANS: Amend section 350-2(f), HRS.

JUSTIFICATION: Without the correction section 350-2(f), HRS, is nonsensical. Also, using "child care facility" throughout the subsection provides needed clarity.

Impact on the public: The amendment to section 350-2(f), HRS, supports access to information for parents and guardians of children by clarifying that the department may release confirmed reports of child abuse or neglect with proper consent.
