## A BILL FOR AN ACT

RELATING TO AUTONOMOUS MOTOR VEHICLES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1           SECTION 1. The legislature finds that a modern and obvious  
2 innovation that should be explored in Hawaii is autonomous, or  
3 "driverless", motor vehicles, which can potentially save lives  
4 and reduce commuting times. The Institute of Electrical and  
5 Electronics Engineers has predicted that seventy-five per cent  
6 of vehicles will be "driverless" by 2040. It would therefore  
7 benefit our state to prepare for inevitable technological  
8 advances and authorize, for testing purposes, the operation of  
9 autonomous vehicles. Thus far, California, Florida, and Nevada  
10 have all approved driverless vehicle testing on their roads, and  
11 Georgia is considering it as well. Outside of the United  
12 States, Japan conducted its first test of driverless vehicles on  
13 a public road in 2013, with the United Kingdom scheduled to do  
14 the same in 2015.

15           The purpose of this Act is to authorize, for testing  
16 purposes, the operation of autonomous vehicles in this state.



1 SECTION 2. Chapter 286, Hawaii Revised Statutes, is  
2 amended by adding a new part to be appropriately designated and  
3 to read as follows:

4 "PART . AUTONOMOUS VEHICLES

5 §286-A Authorization. The director shall authorize, no  
6 later than January 1, 2018, the development of an autonomous  
7 vehicle testing program, to be administered by the department of  
8 transportation.

9 §286-B Application and approval process. The department  
10 shall establish, no later than January 1, 2019, an application  
11 and approval process by which autonomous vehicle manufacturers  
12 and other interested parties may seek to test autonomous  
13 vehicles in the State. Prior to granting any approval for  
14 testing, the department shall require, at a minimum,  
15 satisfactory evidence of the following:

- 16 (a) The applicant's safety record;
- 17 (b) The applicant's insured or bonded status;
- 18 (c) The autonomous vehicle's safety features, including  
19 the presence of a manual override feature; and
- 20 (d) The ease with which the autonomous vehicle's operator  
21 can activate and deactivate the autonomous technology.



1           **§286-C Fees.** The department may assess any fees necessary  
2 to cover the costs of application processing and program  
3 administration.

4           **§286-D Rules.** The department shall adopt rules under  
5 chapter 91 to implement this part.

6           **§286-E Penalties.** The department shall establish  
7 administrative penalties for noncompliance with the requirements  
8 of this part or with rules adopted pursuant to chapter 91.

9           **§286-F Reports to the legislature.** (a) No later than  
10 twenty days prior to the convening of each regular session, and  
11 beginning with the regular session of 2020, the director shall  
12 submit a report to the legislature that addresses the following:

- 13           (1) The feasibility and safety implications of authorizing  
14           the operation of autonomous vehicles beyond the  
15           testing phase;
- 16           (2) The adoption or amendment of relevant administrative  
17           rules issued pursuant to this part;
- 18           (3) Any additional legislative action that may be required  
19           for the safe testing and operation of autonomous  
20           vehicles; and



1           (4) Detailed information on the autonomous vehicle  
2                   manufacturers and other interested parties who  
3                   submitted applications pursuant to section 286-B  
4                   during the preceding twelve-month period."

5           SECTION 3. There is appropriated out of the general  
6 revenues of the State of Hawaii the sum of \$\_\_\_\_\_ or so much  
7 thereof as may be necessary for fiscal year 2017-2018 and the  
8 same sum or so much thereof as may be necessary for fiscal year  
9 2018-2019 for the establishment of the autonomous vehicle  
10 testing program and any associated costs.

11           The sums appropriated shall be expended by the department  
12 of transportation for the purposes of this Act.

13           SECTION 4. In codifying the new sections added by section  
14 2 of this Act, the revisor of statutes shall substitute  
15 appropriate section numbers for the letters used in designating  
16 the new sections in this Act.

17           SECTION 5. This Act shall take effect on July 1, 2019.
