
A BILL FOR AN ACT

RELATING TO THE OFFICE OF THE PUBLIC DEFENDER OPERATING BUDGET.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to provide funding
2 for the operations of the office of the public defender for the
3 fiscal biennium beginning July 1, 2019, and ending June 30,
4 2021, under the purview of the house of representatives standing
5 committee on judiciary.

6 SECTION 2. DEFINITIONS. Unless otherwise clear from the
7 context, as used in this Act:

8 "Expending agency" means the executive department,
9 independent commission, bureau, office, board, or other
10 establishment of the state government (other than the
11 legislature, office of Hawaiian affairs, and judiciary), the
12 political subdivisions of the State, or any quasi-public
13 institution supported in whole or in part by state funds, which
14 is authorized to expend specified appropriations made by this
15 Act.



1 Abbreviations, where used to denote the expending agency or
2 a house of representatives standing committee, shall mean the
3 following:

4 BUF Department of budget and finance

5 "Means of financing" or "MOF" means the source from which
6 funds are appropriated or authorized to be expended for the
7 programs and projects specified in this Act. All appropriations
8 are followed by letter symbols. The letter symbols, where used,
9 shall have the following meanings:

10 A General funds

11 "Position ceiling" means the maximum number of permanent
12 and temporary full-time equivalent positions authorized for a
13 particular program during a specified period or periods, as
14 denoted by an asterisk for permanent full-time equivalent
15 positions and a pound sign for temporary full-time equivalent
16 positions.

17 "Program ID" means the unique identifier for the specific
18 program and consists of the abbreviation for the organization
19 responsible for carrying out the program followed by the
20 organization number for the program.



1 SECTION 3. The following sums, or so much thereof as may
2 be sufficient to accomplish the purposes and programs designated
3 herein, are hereby appropriated or authorized, as the case may
4 be, from the means of financing specified to the expending
5 agencies designated for the fiscal biennium beginning July 1,
6 2019, and ending June 30, 2021. The total expenditures and the
7 number of positions in each fiscal year of the biennium shall
8 not exceed the sums and the position ceilings indicated for each
9 fiscal year, except as provided elsewhere in this Act or as
10 provided by general law.
