# A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES BUDGET.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1                                   **PART I. GENERAL PROVISIONS**

2           SECTION 1. The purpose of this Act is to adjust the  
3 operating budget for the fiscal biennium beginning July 1, 2019,  
4 and ending June 30, 2021, using the Supplemental Appropriations  
5 Act of 2018 as a basis for the appropriations and  
6 authorizations, for certain state executive branch programs  
7 under the purview of the house of representatives standing  
8 committee on water, land, and Hawaiian affairs.

9           SECTION 2. Unless otherwise clear from the context, as  
10 used in this Act:

11           "Expending agency" means the department of land and natural  
12 resources.

13           Abbreviations, where used to denote the expending agency or  
14 a house of representatives standing committee, shall mean the  
15 following:

16           LNR Department of land and natural resources



1           WLH House of representatives standing committee on water,  
2                   land, and Hawaiian affairs

3           "Means of financing" or "MOF" means the source from which  
4 funds are appropriated or authorized to be expended for the  
5 programs and projects specified in this Act. All appropriations  
6 are followed by letter symbols. The letter symbols, where used,  
7 shall have the following meanings:

8           A     General funds  
9           B     Special funds  
10          N     Federal funds  
11          P     Other federal funds  
12          T     Trust funds

13          "Program ID" means the unique identifier for the specific  
14 program and consists of the abbreviation for the organization  
15 responsible for carrying out the program followed by the  
16 organization number for the program.

17                                   **PART II. PROGRAM APPROPRIATIONS**

18          SECTION 3. The following sums, or so much thereof as may  
19 be sufficient to accomplish the purposes and programs designated  
20 herein, are hereby appropriated or authorized, as the case may  
21 be, from the means of financing specified to the expending



1 agency designated for the fiscal biennium beginning July 1,  
2 2019, and ending June 30, 2021. The total expenditures in each  
3 fiscal year of the biennium shall not exceed the sums indicated  
4 for each fiscal year, except as provided elsewhere in this Act  
5 or as provided by general law. Negative amounts reflect a  
6 reduction in appropriations, or authorizations, as the case may  
7 be, from the amounts appropriated or authorized in the fiscal  
8 year 2018-2019 base budget, otherwise known as the Supplemental  
9 Appropriations Act of 2018.

1                   PART III. MISCELLANEOUS AND EFFECTIVE DATE

2           SECTION 4. If any portion of this Act or its application  
3 to any person, entity, or circumstance is held to be invalid for  
4 any reason, then the legislature declares that the remainder of  
5 this Act and each and every other provision thereof shall not be  
6 affected thereby. If any portion of a specific appropriation is  
7 held to be invalid for any reason, the remaining portion shall  
8 be expended to fulfill the objective of the appropriation to the  
9 extent possible.

10          SECTION 5. If manifest clerical, typographical, or other  
11 mechanical errors are found in this Act, the governor may  
12 correct the errors.

13          SECTION 6. This Act shall take effect on July 1, 2019.
