
A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I. GENERAL PROVISIONS

1
2 SECTION 1. The purpose of this Act is to establish the
3 operating budget for the fiscal biennium beginning July 1, 2019,
4 and ending June 30, 2021, for the department of health.

5 SECTION 2. DEFINITIONS. Unless otherwise clear from the
6 context, as used in this Act:

7 "Expending agency" means the department of health,
8 department of public safety, an independent commission, bureau,
9 office, board, or other establishment of the state government
10 (other than the legislature, office of Hawaiian affairs, and
11 judiciary), the political subdivisions of the State, or any
12 quasi-public institution supported in whole or in part by state
13 funds, which is authorized to expend specified appropriations
14 made by this Act.

15 Abbreviations, where used to denote the expending agency or
16 a house of representatives standing committee, shall mean the
17 following:



1 HLT House of representatives standing committee on health

2 HTH Department of health

3 "Means of financing" or "MOF" means the source from which
4 funds are appropriated or authorized to be expended for the
5 programs and projects specified in this Act. All appropriations
6 are followed by letter symbols. The letter symbols, where used,
7 shall have the following meanings:

8 A General funds

9 B Special funds

10 N Federal funds

11 P Other federal funds

12 U Interdepartmental transfers

13 "Position ceiling" means the maximum number of permanent
14 and temporary full-time equivalent positions authorized for a
15 particular program during a specified period or periods, as
16 denoted by an asterisk for permanent full-time equivalent
17 positions and a pound sign for temporary full-time equivalent
18 positions.

19 "Program ID" means the unique identifier for the specific
20 program and consists of the abbreviation for the organization
21 responsible for carrying out the program followed by the
22 organization number for the program.



1 **PART II. PROGRAM APPROPRIATIONS**

2 SECTION 3. APPROPRIATIONS. The following sums, or so much
3 thereof as may be sufficient to accomplish the purposes and
4 programs designated herein, are hereby appropriated or
5 authorized, as the case may be, from the means of financing
6 specified to the expending agencies designated for the fiscal
7 biennium beginning July 1, 2019, and ending June 30, 2021. The
8 total expenditures and the number of positions in each fiscal
9 year of the biennium shall not exceed the sums and the position
10 ceilings indicated for each fiscal year, except as provided
11 elsewhere in this Act or as provided by general law.

1 **PART III. MISCELLANEOUS AND EFFECTIVE DATE**

2 SECTION 4. If any portion of this Act or its application
3 to any person, entity, or circumstance is held to be invalid for
4 any reason, then the legislature declares that the remainder of
5 the Act and each and every other provision thereof shall not be
6 affected thereby. If any portion of a specific appropriation is
7 held to be invalid for any reason, the remaining portion shall
8 be expended to fulfill the objective of the appropriation to the
9 extent possible.

10 SECTION 5. If manifest clerical, typographical, or other
11 mechanical errors are found in this Act, the governor may
12 correct the errors.

13 SECTION 6. This Act shall take effect on July 1, 2020.
