
A BILL FOR AN ACT

RELATING TO THE BUDGET OF THE OFFICE OF THE LIEUTENANT GOVERNOR.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I. GENERAL PROVISIONS

1
2 SECTION 1. The purpose of this Act is to establish
3 additional amounts to be appropriated or authorized and
4 additional positions in the operating budget for the fiscal
5 biennium beginning July 1, 2019, and ending June 30, 2021, for
6 the office of the lieutenant governor.

7 SECTION 2. DEFINITIONS. Unless otherwise clear from the
8 context, as used in this Act:

9 "Expending agency" means the executive department,
10 independent commission, bureau, office, board, or other
11 establishment of the state government (other than the
12 legislature, office of Hawaiian affairs, and judiciary), the
13 political subdivisions of the State, or any quasi-public
14 institution supported in whole or in part by state funds, which
15 is authorized to expend specified appropriations made by this
16 Act.



1 Abbreviations, where used to denote the expending agency or
2 a house of representatives standing committee, shall mean the
3 following:

4 LTG Office of the lieutenant governor

5 LMG House of representatives standing committee on
6 legislative management

7 "Means of financing" or "MOF" means the source from which
8 funds are appropriated or authorized to be expended for the
9 programs and projects specified in this Act. All appropriations
10 are followed by letter symbols. The letter symbols, where used,
11 shall have the following meanings:

12 A General funds

13 "Position ceiling" means the maximum number of permanent
14 and temporary full-time equivalent positions authorized for a
15 particular program during a specified period or periods, as
16 denoted by an asterisk for permanent full-time equivalent
17 positions and a pound sign for temporary full-time equivalent
18 positions.

19 "Program ID" means the unique identifier for the specific
20 program and consists of the abbreviation for the organization



1 responsible for carrying out the program followed by the
2 organization number for the program.

3 **PART II. PROGRAM APPROPRIATIONS**

4 SECTION 3. APPROPRIATIONS. The following sums, or so much
5 thereof as may be sufficient to accomplish the purposes and
6 programs designated herein, are hereby appropriated or
7 authorized, as the case may be, from the means of financing
8 specified to the expending agencies designated for the fiscal
9 biennium beginning July 1, 2019, and ending June 30, 2021. The
10 total expenditures and the number of positions in each fiscal
11 year of the biennium shall not exceed the sums and the position
12 ceilings indicated for each fiscal year, except as provided
13 elsewhere in this Act or as provided by general law.

1 **PART III. PROGRAM APPROPRIATION PROVISIONS**

2 SECTION 4. Provided that of the general fund
3 appropriations for the office of the lieutenant governor
4 (LTG100):

5 (1) The sum of \$ or so much thereof as may be
6 necessary for fiscal year 2019-2020 shall be expended
7 to upgrade computer equipment; and

8 (2) The sum of \$ or so much thereof as may be
9 necessary for fiscal year 2019-2020 shall be expended
10 for Cat6 cabling for VOIP telephones.

11 **PART IV. MISCELLANEOUS AND EFFECTIVE DATE**

12 SECTION 5. If any portion of this Act or its application
13 to any person, entity, or circumstance is held to be invalid for
14 any reason, then the legislature declares that the remainder of
15 the Act and each and every other provision thereof shall not be
16 affected thereby. If any portion of a specific appropriation is
17 held to be invalid for any reason, the remaining portion shall
18 be expended to fulfill the objective of the appropriation to the
19 extent possible.

1 SECTION 6. If manifest clerical, typographical, or other
2 mechanical errors are found in this Act, the governor may
3 correct the errors.

4 SECTION 7. This Act shall take effect on July 1, 2022.
