
A BILL FOR AN ACT

RELATING TO THE STATE PUBLIC CHARTER SCHOOLS BUDGET.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I. GENERAL PROVISIONS

1 **PART I. GENERAL PROVISIONS**
2 SECTION 1. The purpose of this Act is to establish
3 additional amounts to be appropriated or authorized and
4 additional positions in the operating budget for the fiscal
5 biennium beginning July 1, 2019, and ending June 30, 2021, for
6 certain state executive branch programs under the purview of the
7 house of representatives standing committee on lower and higher
8 education.

9 SECTION 2. Unless otherwise clear from the context, as
10 used in this Act:

11 "Expending agency" means the department of education.

12 Abbreviations, where used to denote the expending agency
13 shall mean the following:

14 EDN Department of education

15 "Means of financing" or "MOF" means the source from which
16 funds are appropriated or authorized to be expended for the
17 programs and projects specified in this Act. All appropriations



1 are followed by letter symbols. The letter symbols, where used,
2 shall have the following meanings:

3 A General funds

4 "Position ceiling" means the maximum number of permanent
5 and temporary full-time equivalent positions authorized for a
6 particular program during a specified period or periods, as
7 denoted by an asterisk for permanent full-time equivalent
8 positions and a pound sign for temporary full-time equivalent
9 positions.

10 "Program ID" means the unique identifier for the specific
11 program and consists of the abbreviation for the organization
12 responsible for carrying out the program followed by the
13 organization number for the program.

14 **PART II. PROGRAM APPROPRIATIONS**

15 SECTION 3. The following sums, or so much thereof as may
16 be sufficient to accomplish the purposes and programs designated
17 herein, are hereby appropriated or authorized, as the case may
18 be, from the means of financing specified to the expending
19 agencies designated for the fiscal biennium beginning July 1,
20 2019, and ending June 30, 2021. The total expenditures and the
21 number of positions in each fiscal year of the biennium shall



1 not exceed the sums and the position ceilings indicated for each
2 fiscal year, except as provided elsewhere in this Act or as
3 provided by general law.

1 **PART III. MISCELLANEOUS AND EFFECTIVE DATE**

2 SECTION 4. Notwithstanding any other law to the contrary,
3 an appropriation made to a program by this Act may be combined
4 with appropriations made to the same program by any other Act
5 enacted by the legislature for the 2019-2021 fiscal biennium if
6 the combination is advantageous or convenient for budget
7 execution.

8 SECTION 5. If any portion of this Act or its application
9 to any person, entity, or circumstance is held to be invalid for
10 any reason, then the legislature declares that the remainder of
11 the Act and each and every other provision thereof shall not be
12 affected thereby. If any portion of a specific appropriation is
13 held to be invalid for any reason, the remaining portion shall
14 be expended to fulfill the objective of the appropriation to the
15 extent possible.

16 SECTION 6. If manifest clerical, typographical, or other
17 mechanical errors are found in this Act, the governor may
18 correct the errors.

19 SECTION 7. This Act shall take effect on July 1, 2055.
