
A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF AGRICULTURE OPERATING BUDGET.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to provide funding
2 for the operations of the department of agriculture for the
3 fiscal biennium beginning July 1, 2019, and ending June 30,
4 2021.

5 SECTION 2. The following sums, or so much thereof as may
6 be sufficient to accomplish the purposes and programs designated
7 herein, are hereby appropriated or authorized, as the case may
8 be, from the means of financing specified to the department of
9 agriculture for the fiscal biennium beginning July 1, 2019, and
10 ending June 30, 2021. The total expenditures and the number of
11 positions in each fiscal year of the biennium shall not exceed
12 the sums and the position ceilings indicated for each fiscal
13 year, except as provided elsewhere in this Act or as provided by
14 general law.
