# A BILL FOR AN ACT

MAKING EMERGENCY APPROPRIATIONS FOR PUBLIC EMPLOYMENT COST  
ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. This Act is recommended by the governor for  
3 immediate passage in accordance with section 9 of article VII of  
4 the Constitution of the State of Hawaii.

5 SECTION 2. There are appropriated from the sources of  
6 funding indicated below to collective bargaining statewide (BUF  
7 102) the following sums or so much thereof as may be necessary  
8 to fund for fiscal biennium 2019-2021 all collective bargaining  
9 cost items in the agreement negotiated with the exclusive  
10 representative of collective bargaining unit (2):

7 SECTION 3. Funds appropriated by this part shall be  
8 allotted by the director of finance to the appropriate state  
9 departments for expenditure in the respective fiscal year for  
10 the purposes of this part.

12 SECTION 4. There is appropriated from the source of  
13 funding indicated below to administration (JUD 601) the  
14 following sums or so much thereof as may be necessary to fund  
15 for fiscal biennium 2019-2021 all collective bargaining cost  
16 items in the agreement negotiated with the exclusive  
17 representative of collective bargaining unit (2):

1 SECTION 5. Funds appropriated by this part shall be  
2 expended by the chief justice in the respective fiscal year for  
3 the purposes of this part.

5 SECTION 6. There are appropriated from the sources of  
6 funding indicated below to collective bargaining statewide (BUF  
7 102) the following sums or so much thereof as may be necessary  
8 to fund for fiscal biennium 2019-2021 the salary increases and  
9 other cost adjustments authorized by chapter 89C, Hawaii Revised  
10 Statutes, for state officers and employees who are excluded from  
11 collective bargaining and belong to the same compensation plans  
12 as those officers and employees within bargaining unit (2):

16 SECTION 7. Funds appropriated by this part shall be  
17 allotted by the director of finance to the appropriate state  
18 departments for expenditure in the respective fiscal year for  
19 the purposes of this part.

1 SECTION 8. There is appropriated from the source of  
 2 funding indicated below to Hawaii health systems corporation -  
 3 corporate office (HTH 210) the following sums or  
 4 so much thereof as may be necessary to fund for fiscal biennium  
 5 2019-2021 the collective bargaining cost items in the agreement  
 6 negotiated with the exclusive representative of collective  
 7 bargaining unit (2) who is assigned to the Hawaii health systems  
 8 corporation:

11 SECTION 9. Funds appropriated by this part shall be  
 12 allotted by the director of finance to the Hawaii health systems  
 13 corporation for expenditure in the respective fiscal year for  
 14 the purposes of this part.

15 PART V

16 SECTION 10. Salary increases and cost adjustments provided  
 17 in this Act for any officer or employee whose compensation is  
 18 paid, in whole or in part, from federal, special, or other funds  
 19 shall be paid wholly or proportionately, as the case may be,  
 20 from the respective funds.



1 SECTION 11. Funds appropriated or authorized by this Act  
2 that are not expended or encumbered by June 30, 2021, shall  
3 lapse as of that date.

4 SECTION 12. This Act shall take effect on January 1, 2050.
