## A BILL FOR AN ACT

RELATING TO THE CONFERENCE CENTER REVOLVING FUND.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Section 304A-2272, Hawaii Revised Statutes, is  
2 amended to read as follows:

3           "~~[†]~~§304A-2272~~[†]~~ **Conference center revolving fund;**  
4 **University of Hawaii at Hilo.** (a) There is established the  
5 conference center revolving fund for ~~[the]~~ conference center  
6 ~~[program in the college of continuing education and community~~  
7 ~~service of]~~ programs conducted by the University of Hawaii at  
8 Hilo. All fees, charges, and other moneys collected in  
9 conjunction with the conference center ~~[program]~~ programs shall  
10 be deposited in the revolving fund. The ~~[dean of the college of~~  
11 ~~continuing education and community service]~~ University of Hawaii  
12 at Hilo chancellor or designee is authorized to expend funds  
13 from the revolving fund for all costs associated with conducting  
14 conferences, seminars, and courses by the conference center  
15 ~~[program]~~ programs, including but not limited to expenses for  
16 honoraria, hotel and room rentals, food and refreshment,  
17 printing and mailing, airfare and per diem, ~~[leis]~~ lei, rental  
18 of audiovisual equipment, and conference supplies and

1 materials[-], without regard to any competitive bidding  
2 requirements pursuant to state procurement requirements.

3 (b) The chancellor of the University of Hawaii at Hilo  
4 shall prepare an annual report to the legislature accounting for  
5 all income and expenditures within the revolving fund."

6 SECTION 2. Statutory material to be repealed is bracketed  
7 and stricken. New statutory material to be added is  
8 underscored.

9 SECTION 3. This Act, upon its approval, shall take effect  
10 on July 1, 2020.

JUSTIFICATION SHEET

DEPARTMENT: University of Hawaii

TITLE: A BILL FOR AN ACT RELATING TO THE CONFERENCE CENTER REVOLVING FUND.

PURPOSE: Broadens the scope of the Conference Center Revolving Fund for the University of Hawaii at Hilo.

MEANS: Amend section 304A-2272, Hawaii Revised Statutes (HRS).

JUSTIFICATION: The purpose of this Act is to broaden the statutory language for the Conference Center Revolving Fund for the University of Hawaii at Hilo.

The fund is no longer being used as the College of Continuing Education and Community Service no longer exists. This bill would expand use to the University of Hawaii at Hilo Chancellor or their designee.

Additionally, an exemption from the State Procurement Code, is included to allow for more efficient use of resources for conferences and classes being conducted at the Conference Center. Accordingly, a reporting requirement has been added to the statute.
