## A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE  
TWENTY-NINTH REPRESENTATIVE DISTRICT.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The director of finance is authorized to issue  
2 general obligation bonds in the sum of \$5,500,000 or so much  
3 thereof as may be necessary and the same sum or so much thereof  
4 as may be necessary is appropriated for fiscal year 2020-2021  
5 for the purpose of capital improvement projects for the twenty-  
6 ninth representative district, as follows:

7    1. Lanakila district park baseball field  
8       Plans, construction, and equipment for  
9       shed replacement and maintenance.

11	Construction	\$25,000
12	Equipment	\$10,000

13	Total funding	\$50,000

14           The sum appropriated for this capital improvement project  
15 shall be expended by the city and county of Honolulu.



1 2. Kalihi Kai elementary

7 The sum appropriated for this capital improvement project  
8 shall be expended by the department of education.

13 fence.

14 Plans \$25,000

15 Design \$25,000

16 Construction \$150,000

17 Equipment \$100,000

18 Total funding \$300,000

19 The sum appropriated for this capital improvement project  
20 shall be expended by the department of education.



1 4. Shoreline remediation for Sand Island

2 State Park

3 Plans, design, construction, and

4 equipment for shoreline remediation.

5 Plans \$1,000,000

6 Design \$1,000,000

7 Construction \$2,000,000

8 Equipment \$1,000,000

9 Total funding \$5,000,000

10 The sum appropriated for this capital improvement project  
11 shall be expended by the department of land and natural  
12 resources.

13 SECTION 2. The appropriation made for the capital  
14 improvement projects authorized by this Act shall not lapse at  
15 the end of the fiscal year for which the appropriation is made;  
16 provided that all moneys from the appropriation unencumbered as  
17 of June 30, 2022, shall lapse as of that date.
